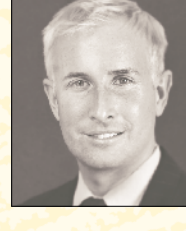

Distinguished Achievement Award

The California Academy of Sciences and Contemporary Jewish Museum



The California Academy of Sciences is one of the world's preeminent natural history museums and is an international leader in scientific research about the natural world. Founded in 1853 as the first scientific institution in the West, it is home to the Steinhart Aquarium, Morrison Planetarium, and Kimball Natural History Museum. The Academy's mission—to explore, explain, and protect the natural world—extends to all corners of the institution: from research expeditions to teacher training programs and interactive exhibits on the museum floor.

Since its founding in 1984, the Contemporary Jewish Museum has engaged audiences of all ages and backgrounds through engaging exhibitions and programs that explore contemporary perspectives on Jewish culture, history, art, and ideas.



In 1990, the Museum's leadership began planning for a more expansive facility. A few years later the San Francisco Redevelopment Agency invited the Museum to develop the historic Jessie Street PG&E Power Substation. In 1998, the Museum selected architect Daniel Libeskind to design its new home. Libeskind's visionary design as a dynamic and welcoming space enables and inspires the experience of art, music, film, literature, debate, and—most importantly—other people.

Embracing a range of artistic disciplines and media, the Museum's exhibition program includes contemporary art and historical objects, film and music, conversations, lectures, literary readings, and other live performance. The Contemporary Jewish Museum is a non-collecting institution that partners with national and international cultural institutions to present exhibitions that are timely and that represent the highest level of artistic achievement and scholarship. At the heart of our programs is a focus on education and outreach to the broader community with the goal of fostering interfaith and intercultural dialogues.

Since 1986, the Chronicle Season of Sharing Fund has distributed more than \$61 million to help our neighbors in the nine-county Bay Area. One hundred percent of the money raised goes directly to those who need it most. Each year, the fund resolves critical needs and housing assistance issues and provides thousands of emergency meals for people who might otherwise go hungry. A record \$5.2 million was raised during the 2007-08 campaign.

Hank Rosso Outstanding Fundraising Professional

The Hank Rosso Outstanding Fundraising Professional Award honors an individual who creatively organizes fundraising campaigns that result in successful fund development—someone who keeps the spirit of the legendary fundraiser Hank Rosso alive through their professional leadership and commitment to the field of fundraising.



Cheri Bryant

Cheri Bryant believes that genuine partnerships between donors and nonprofits enable a synergy far beyond the dollar value of donors' gifts. She also feels that working with donors and volunteers is what makes fundraising enjoyable and rewarding! She has served as the Director of Development for the American Civil Liberties Union of Northern California since 1990 and has led charitable fundraising campaigns for more than 25 years. During her tenure, annual contributions to the ACLU of Northern California have increased four-fold, membership has quadrupled, the organization has completed a successful first-ever endowment campaign, and the ACLU is currently 76% to goal on its campaign to buy its new San Francisco headquarters. Bryant serves as a mentor to development staff, not only within the ACLU network but also in other Bay Area social change groups, and serves on ACLU nationwide committees to plan and coordinate major fundraising initiatives. She has also lectured on board development and individual-gift fundraising. Prior to her work at the ACLU, Bryant headed fundraising for the Oakland Symphony, the Horizons Foundation, the Trust for Public Land, and University of California-Berkeley's College of Letters and Science. Cheri Bryant first became a student of Hank Rosso's in 1981 and to this day follows and teaches his basic principles of ethical and effective fundraising.

Outstanding Fundraising Volunteer

The Outstanding Fundraising Volunteer Award celebrates an individual who has demonstrated exceptional leadership and commitment by motivating and inspiring other volunteers in successful fundraising endeavors.

Sheryl Wong

Sheryl Wong has been fundraising nearly her whole life...from work with Girl Scouts, to raising money for migrant families. As a former teacher, her philanthropy and volunteerism focuses on education. As Chair of the Oakland Museum of California Foundation, she worked with the boards of the Oakland Zoo and Chabot Space and Science Center to put a bond measure on the ballot to support the education focus of the institutions. The passage of that measure by 75% of Oakland voters provided the seed money for the museum's current capital campaign. As both Board and Campaign chair, Sheryl has been the volunteer leader of the \$53 million effort, raising nearly \$49 million, so far. She also served as the Alameda-Contra Costa Committee co-chair for UC Berkeley's "Campaign for the New Century", which raised a total of \$1.4 billion, campus wide. As president of UC Berkeley's Library Advisory Board, she served on the leadership committee that raised \$33 million in three years for the Bancroft Library, without having a public phase. Ms. Wong currently serves as a trustee of the UC Berkeley Foundation Board and is a director of the Bay Area Tumor Institute.



She and her husband Bob live in Piedmont. Her son Christopher and his wife, Siam, carry on the tradition of volunteerism and philanthropy, having just chaired his Duke MBA graduating class campaign and raising the most money for an MBA class thus far.

The Outstanding Foundation Professional Award honors an individual whose work exemplifies leadership and exceptional achievement in the field of grantmaking.



Dianne Yamashiro-Omi

Dianne Yamashiro-Omi joined The California Endowment in 2000, and is currently senior program officer for Culturally Competent Health Systems, for which she oversees the grant-making activities of the foundation's program. She works closely with the program's director, Ignatius Bau, to help advance The Endowment's goal and overall mission.

Yamashiro-Omi has more than 20 years of experience in philanthropy. Prior to her current appointment, she was senior program officer for The Endowment's Greater Bay Area regional office located in San Francisco, where she oversaw all administrative and grant-making activities for that region. Additionally, she served as staff leader for the foundation's investments in community-based "focus funds," which are small, vibrant grant-making nonprofits created by people connected not just by location, as with community foundations, but also by shared experience and culture. These funds help fill important needs that mainstream foundations are typically unable to meet.

Prior to joining The Endowment, she served as a foundation consultant with several organizations including the Levi Strauss Foundation, the Evelyn and Walter Haas Jr. Fund, the Civil Liberties Public Education Fund, the Asian Pacific American Community Fund and the San Francisco Foundation. She also served as a program officer with the Koret Foundation and the Gap Foundation. In addition, she served as executive director of the Asian Foundation for Community Development, co-director of Asian Health Services and executive director of Asian Manpower, Inc. She holds a bachelor's degree in Social Science from U.C. Berkeley and a teaching credential from the University of San Francisco.

Outstanding Youth In Philanthropy

The Outstanding Youth in Philanthropy Award recognizes a high school or college youth leader or youth-generated project and its team that has significantly impacted the Bay Area Community. The awardee has learned the philanthropic tradition and values associated with supporting one's community.

Youth United for Community Action

YUCA is a grassroots organization created, led, and run by young people of color, predominantly from low-income communities. YUCA provides a safe space for learning self-empowerment through working on environmental and social justice issues, with the goal of establishing positive systemic change through grassroots community organizing.



YUCA began in 1994 as a summer program and expanded to become a full-fledged organization in 1997 through the creation of the Higher Learning Program, a program created by and for high school-aged youth. Historically, our focus has been on important issues affecting our community of East Palo Alto. For example, in August 2007, we ran a successful environmental justice campaign to shut down the hazardous waste facility, Romic. We are continuing our work on that campaign to ensure the proper closure and thorough clean-up of the facility.

Similarly, in our efforts toward social justice, we are working to ensure that gentrification does not occur, as it has in so many other low income, urban communities. We are focusing on curbing tenant displacement from their homes and helping to ensure that the community decides on the best possible future vision of East Palo Alto through the incoming developments.

Outstanding Foundation or Community Grantmaker

The Outstanding Foundation or Community Grantmaker Award celebrates an organization successfully meeting community needs through financial support and encouraging others to assume leadership roles in philanthropy and community involvement.

The California Wellness Foundation



is an independent, private foundation created in 1992, with a mission to improve the health of the people of California by making grants for health promotion, wellness education and disease preven-

tion. The Foundation prioritizes eight issues for funding: diversity in the health professions, environmental health, healthy aging, mental health, teenage pregnancy prevention, violence prevention, women's health, and work and health. It also responds to timely issues or special projects outside the funding priorities. TCWF is one of the state's largest foundations. Since its first year of operation, the Foundation has awarded 5,169 grants totaling more than \$641 million. Last year, TCWF awarded \$64 million in grants in pursuit of its mission.

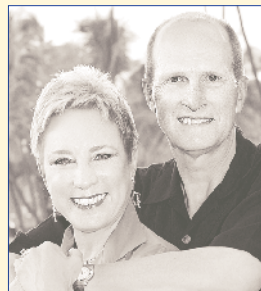

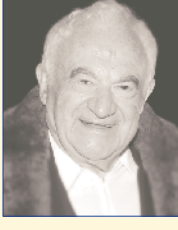
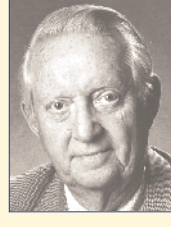


Nina Barbalacci

Co-founder of Warm Wishes, Nina Barbalacci along with her husband Bill Hamm, started the non-profit organization 13 years ago to give winter clothing to the homeless during the holiday season. Nina and Bill ran Warm Wishes as a *mom-and-pop* operation even as it grew larger every holiday season until they were distributing 5,000 backpacks a year. To date, Warm Wishes has distributed more than 35,000 “streetpacks” to homeless adults and children. A team of volunteers gather each year to fill the backpacks with gloves, socks, scarves, ponchos, cookies and handmade cards.

Johnson “Jack” Bogart

Johnson “Jack” Bogart was a real estate figure who spearheaded efforts to move and transform the Asian Art Museum of San Francisco. After being appointed to the Asian Art Commission in 1992, he assumed various leadership roles until 1996, when he took on the dual role of chair for both the Commission and Museum Foundation. Associates credited Mr. Bogart with being the driving force behind the museum’s successful move in March 2003 from an annex without its own entrance at the de Young Museum to a \$170 million home in the refurbished Main Library on Civic Center Plaza.

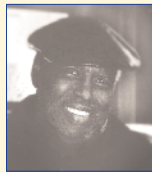


Joseph Brucia

Joseph Bernard Brucia was the son of Giuseppe Brucia, one of ten Italian Americans who underwrote the San Francisco Opera in 1922. Joseph Brucia shared his father’s love for opera, and it became a lifelong passion. In the spring of 2006, Joseph Brucia and his wife, Frances, funded San Francisco’s first-ever outdoor simulcast of the opera, a free performance of “Madama Butterfly” that was beamed from the War Memorial Opera House onto large television screens and speakers in Civic Center Plaza. More than 8,000 people attended the event. In December, Mr. Brucia received the Man of the Year Award from Il Cenacolo, the Italian American club founded in 1928 that still meets every week at Fior d’Italia restaurant on Mason Street.

Eugene Coleman

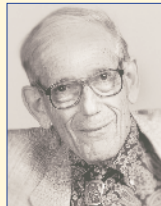
Eugene Coleman was a major force in San Francisco's political and nonprofit worlds who retired in 2006 as the deputy director of the Mayor's Office of Community Development. Mr. Coleman became a city employee in 1984, first as an ombudsman, then as senior planner at the Planning Department and finally as deputy director of the Mayor's Office. He was active on nearly 50 boards of directors, committees, foundations and other groups at one time or another, including St. Anthony Foundation, the local Homeless Coordinating Board and Golden Gate Services for Seniors. Mr. Coleman was also very active in the NAACP, the Bay Area Association of Black Social Workers and Black Men of Action. Mr. Coleman's life-time of public service was recognized with the naming of an 85-unit senior housing complex at 328 Tehama St. as the Eugene Coleman Community House.

**Daniel Collins, D.D.S.**

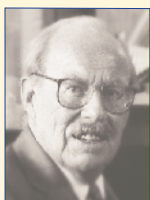
Dr. Daniel Collins was a Marin civil rights pioneer. He was the first African American professor at the University of California at San Francisco's School of Dentistry and one of the first African American men in the country to serve on corporate boards. He founded the Bay Area Urban League and the first African American-owned savings and loan in San Francisco. Dr. Collins helped to create the *Sun-Reporter* newspaper in San Francisco; the Church for the Fellowship of All People, one of the first non denominational, interracial churches in the country; and what today is known as Lifehouse, a residential and counseling center for people with developmental disabilities located in San Rafael. Additionally, he served as a mentor for countless young, African American men and he received an award for his mentoring from the Bay Area Community Development Corp. in San Francisco.

Sigrun Corrigan

Sigrun Corrigan was a patron of the Bay Area arts scene who served as chairwoman and president of Ballet San Jose. Mrs. Corrigan, along with her husband, Wilf Corrigan were avid supporters of San Francisco's Symphony and Opera, as well as Ballet San Jose. Known for her gracious and sparkling personality, Mrs. Corrigan was not just a patron of the arts, but a devotee of the arts. Mrs. Corrigan loved to paint, sketch and designed everything from clothing to furniture to homes. She was president of the Corrigan Walla Foundation, which focused on donating to the arts and the developmentally disabled. Her Norwegian heritage drew her to projects with the Norwegian Consulate in San Francisco and the Norwegian American Cultural Society.

**Benjamin Elkus**

Benjamin Elkus was a member of an early San Francisco family, and was a retired insurance executive. He played a major role in organizing the Elkus Collection of Native American artifacts at the California Academy of Sciences. Anthropology was a family interest—Mr. Elkus' parents had helped the Pueblo Indians of the Southwest regain control of ancestral land and water rights that had been taken by squatters. They also fought for reform of the Bureau of Indian Affairs. After retirement from the insurance business, Mr. Elkus began organizing his parents' papers and collections of Native American art and artifacts, and donated them to the California Academy of Sciences. The Elkus collection includes over 3,300 documents and 1,700 artifacts. Many of the artifacts are on public display and the documents are available to researchers. Active in civic affairs, Mr. Elkus was a member of the Commonwealth Club in San Francisco for over 70 years and was honored by the Lions Club as San Francisco's Lion of the Year in 1968.

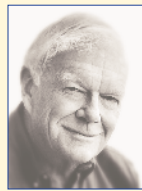


Louis Flynn

Louis Flynn was an actor, director, playwright, and pillar of the East Bay's community theatre scene for half a century. His most visible legacy is Contra Costa Civic Theatre, which he co-founded with his late wife, Bettianne, in El Cerrito in 1959. Louis served as Artistic Director for 48 years, as well as producer, and most prominently, as an actor in thousands of performances. He received several honors from the El Cerrito City Council, recognizing CCCT's contribution to community theatre and acknowledging its commitment to volunteers. In 1978, CCCT's home on Pomona was named "The Flynn Building." Additional honors include the El Cerrito Wall of Fame, Contra Costa County Board of Supervisors Arts Recognition Award and a Certificate of Recognition from the California State Senate acknowledging his outstanding achievements.

Elizabeth Lilienthal and James Mack Gerstley

Elizabeth Lilienthal Gerstley, a civic leader and a descendant of the Forty-Niners who came to California in the Gold Rush, was born in San Francisco at home—in the celebrated Haas-Lilienthal House at 2007 Franklin Street. Elizabeth married James Gerstley who had a long career as an executive in the mining business and was one of the developers of Boraxo, a cleansing product made of Borax mined near Death Valley. Mrs. Gerstley worked tirelessly in such causes as Planned Parenthood, the League of Women Voters, the Nature Conservancy, the Filoli Gardens in Woodside, among others. In 1973, the family presented the Haas-Lilienthal House to the San Francisco Architectural Heritage. Mr. Gerstley was a co-founder of the Asian Art Museum and helped to secure the Avery Brundage collection. He also contributed to numerous other artistic and cultural causes in the Bay Area and California.



George "Fritz" Jewett

George Frederick "Fritz" Jewett, Jr. was a prominent San Francisco businessman, philanthropist and sailing buff whose support of the sport led to his induction into the America's Cup Hall of Fame in 2005. He, along with his wife and three other couples, helped to personally finance salaries for dancers of the San Francisco Ballet in the 1970's when the Ballet was undergoing financial hardship. He served on the board of the California Pacific Medical Center for 41 years. He was chairman of the board of the Asian Art Commission and helped to establish the Asian Art Museum. Mr. Jewett served on the board of directors of the California Academy of Sciences, Mills College, and the Dartmouth Alumni Council as well as the advisory boards of the Monterey Bay Aquarium and the Woods Hole Oceanographic Institute. He also supported the Treasure Island Sailing Center, which provides opportunities for disadvantaged youth.

Debra Kent

Debra Kent was a pioneer fundraiser in the early days of the AIDS epidemic. She helped turn the Academy of Friends into one of the most successful AIDS fundraising organizations in California and a model for other nonprofits. Ms. Kent was executive director of Lyon-Martin Women's Health Services, which focuses on women and transgender people. She raised money with Visiting Nurses and Hospice to create one of the first residential hospice facilities for people with AIDS known as Coming Home Hospice. She later worked at the California Pacific Medical Center Foundation, the San Francisco AIDS Foundation and the UCSF AIDS Research Institute.



Enid Lim

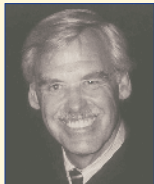
Enid Lim served on numerous San Francisco commissions and advisory boards and was a dedicated advocate for the city's residents of Chinese ancestry. Ms. Lim became known for her work at two prominent Chinese social service organizations and her leadership on neighborhood initiatives. Her efforts brought two new Muni bus lines to Chinatown and got lights and railings placed in the Stockton Street Tunnel. Her biggest achievement was connecting Chinatown's interests with those of greater San Francisco. Ms. Lim served on the city Landmarks Preservation Board, the Access Appeals Board and many other public advisory panels. She also was the emcee for the Chinese New Year Parade for many years. Ms. Lim also served as the inaugural vice president of the city Municipal Transportation Agency board of directors from 2000 to 2003.

**Stuart Moldaw**

Stuart Moldaw was a retail pioneer who founded Ross Stores, Gym-boree, Home Express, Pic-A-Dilly and Athletic Shoe Factory as well as a venture capital firm called U.S. Venture Partners. He served on the boards of a number of local nonprofit groups including the San Francisco Museum of Modern Art, KQED, San Francisco Ballet and the Moldaw-Zaffaroni Boys and Girls Club of East Palo Alto. He took great pleasure in civic involvement. A longtime Democratic donor, he was appointed chairman of California's World Trade commission in 2000 by Gov. Gray Davis. He was appointed to the state's Little Hoover Commission in 2002.

Deb Mosley

Deb Mosley was recognized for creating a support group specifically for young women with breast cancer after receiving her own cancer diagnosis in 2000. When the cancer turned metastatic, she shifted away from her professional life as a lawyer and focused on a series of personal accomplishments, including building a network of support for other young women with breast cancer. She created the Bay Area Young Survivors group with a friend in 2003. Every year, Ms. Mosley would set a challenge for herself and other women who wanted to join her, and they would raise money for Bay Area breast cancer groups, especially those that served low-income women. The first year, Ms. Mosley raised \$42,000 and ran a triathlon in Napa. She would eventually lead a group of women on a hike up Half Dome in 2005 and into the Grand Canyon in 2006. In all, she helped raise more than \$150,000. Ms. Mosley was awarded the Susan G. Komen Hope and Inspiration Award in October 2006.

**C. David Robinson**

C. David Robinson was an architect who left his mark all over the Bay Area. He worked for several San Francisco firms and was a co-founder of Robinson, Mills & Williams, which grew to be one of the five largest architectural firms in San Francisco. In 1997 he founded C. David Robinson Architects. Among his many achievements are museums and private residences, including the Center for the Arts in San Francisco's Yerba Buena Gardens, the Charles M. Schulz Museum in Santa Rosa, major renovations of Temple Emanuel and the landmark Cliff House in San Francisco. Mr. Robinson was active in cultural affairs and was on the boards of the San Francisco Art institute, the University Art Museum at UC Berkeley, the San Francisco Museum of Modern Art, the California College of the Arts, and the San Francisco Planning and Urban Research Association. He received SPUR's Silver Spur award for public service.



Claude Rosenberg

Claude Rosenberg was one of the city's leading investment executives during the 1970's through 1990's. After retiring from the firm he founded, Rosenberg Capital Management, he began a second career aimed at giving away most of his money while trying to persuade other wealthy individuals to be more generous. In 1998, he founded the NewTithing Group, a San Francisco nonprofit that, among other activities, produced an online calculator to help determine how much people could afford to donate to charity.

Mr. Rosenberg was author of several books on investing or philanthropy, including *Wealthy and Wise: How You and America Can Get the Most Out of Your Giving*. With his wife, Louise, Mr. Rosenberg formed a family foundation that directed money to a variety of educational, artistic, social and environmental causes, including Stanford University and the Bay Area Jewish community.

Janet Schultz

Janet Schultz was highly educated, progressive and a woman ahead-of-her-time, who approached everything with a considerable amount of progressive thought. She was a member of many Jewish community organizations, and together with her husband, Albert, made such a large donation to her local JCC that the Albert L. Schultz JCC in Palo Alto was born. An atrium at the center was named after Janet. The couple went on to give many millions of dollars to the local Jewish community, including \$5 million toward the Taube-Koret Campus for Jewish Life in Palo Alto. Janet served as president of the Albert and Janet Schultz Supporting Fund at the S.F.-based Jewish Community Endowment Fund. She passionately supported camp scholarships, helped bring the Wexner Heritage Foundation leadership training program to the Bay Area and showered support upon youth trips to Israel and local day schools. The watchword of both Janet and Albert Schultz was to enhance and maintain Jewish life and ensure Jewish continuity.



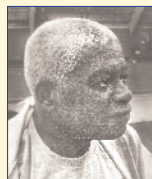
Jack Smith

John "Jack" Smith was a longtime Hayward advocate and the city's first elected mayor. He was a powerful, well-connected lawyer and member of a fourth-generation Hayward family. He received a degree from the UC Hastings College of Law and put it to work locally, helping ranchers and farmers fight the state in eminent domain cases. It was a love for the process—"the art of the deal," friends say—that led Smith to enter city politics. He was elected mayor in 1966 and held that position until 1970. Politics was one

of the many passions he held onto his whole life. He loved supporting people he believed in. Mr. Smith was an inspiration to and great mentor for many young people.

Reuben "Smitty" Smith

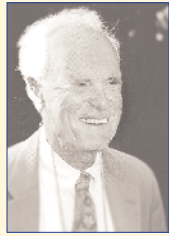
Reuben "Smitty" Smith made sure that the boys and girls of Bay-view-Hunters Point had something to do and somewhere to go. For decades, he was a father figure and mentor to thousands of children but never had any of his own. In 1963, Mr. Smith moved from New York City to the Bay Area to work with the Hunters Point Boys Club and became director seven years later. For more than four decades, Mr. Smith and the club—which later changed its name to include girls—were inseparable. He also belonged to the Rotary Club of San Francisco Bay-view, where he started and coordinated the annual Thanksgiving turkey drive and the Easter ham drive. Although he was an all-around community activist—then-SF Mayor Willie Brown declared Reuben Smith Day on July 20, 2002—children were his passion.



Nancy Stark

Nancy Stark was former executive director of Children's Fairyland who worked tirelessly to restore the outdoor storybook park.

Stark was instrumental in the park's renovation and beautification, lining up donors and enlisting community partners. Local groups, including the Lake Merritt Breakfast Club, joined the effort to turn the park around. Ms. Stark had the vision to see what needed to change. Through her strong leadership personality, she was determined to make sure things got done. The main entrance to Children's Fairyland is dedicated to Stark. She was also an active member of the Lake Merritt Breakfast Club, a licensed marriage and family child counselor, an officer and director of the International Women's Forum and became an artist after retiring from Children's Fairyland in 2002.

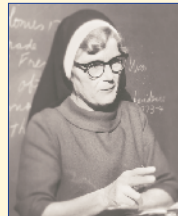
**James Thacher**

James F. Thacher was a longtime San Francisco attorney, philanthropist, sheep rancher and active Democrat. He was a well-known figure in many worlds of San Francisco life from blue-blood charity causes to gritty political campaigns. He was appointed to the state college board of trustees and a toll bridge authority. In the 1970's Mr. Thacher took on independent schools as another interest. He headed the board of trustees of Marin Country Day School in Corte Madera and also led efforts to purchase the

former San Rafael Military Academy and turn it into a new private high school, Marin Academy. The school leaders honored Mr. Thacher's work by naming a science building a lecture series after him. He also supported efforts by his wife, Gladys, who founded the Education Fund in San Francisco in 1979. Since, then, the Ed Fund has grown to become one of the city's largest nonprofit groups supporting public schools through grants for teacher-run projects and classroom programs.

Sister Ethel Mary Tinnemann

Sister Ethel Mary Tinnemann's energy and the classroom and years of political activism earned her the nickname "High-Octane Ethel" from her appreciative students at Holy Names University. Sister Ethel devoted her life to service not just at the university lectern but in the living rooms of Oakland's grittiest neighborhoods, where she signed up generations of voters. She was an expert on the history of the Catholic Church in Nazi Germany. She was a professor for almost 40 years at Holy Names University in Oakland and lectured on German history and modern Europe. Sister Ethel was inducted into California's Voter Participation Hall of Fame in 1999. She served on the Landmarks Preservation Board of Oakland from 1981 to 1986. She researched buildings for the Oakland Cultural Heritage Survey and joined the Oakland Tours Programs as well as serving on the Cameron-Stanford House Board.

**Virginia "Ginny" Yamate**

Virginia "Ginny" Yamate was committed to helping others with care, sensitivity and compassion which was not only reflected throughout her business career, but also in her personal life. She was an active board member for a number of non-profit organizations; among them, the Chinese Newcomers Service Center, Angel Island Immigration Station Foundation, and the San Francisco Education Fund. Her business career spanned over 30 years in broadcasting (radio and TV) in Public Affairs as a producer at

KPIX-TV and as director and manager of Public Affairs at KGO-TV. She then moved to the position of manager of corporate contributions and diversity outreach for AAA Northern California, Nevada & Utah. Ginny received awards for her work from diverse organizations including the International Film & TV Festival of New York, National Assn. of Black Journalists, Northern California Chapter of the National Academy of Television Arts & Sciences, the San Francisco Human Rights Commission, the Pacific Asian American Women's Bay Area Coalition, the AnewAmerica Corporation and many others.



Arthur C. Zief

Arthur C. Zief had a personality and heart larger than life itself according to those who knew him. Zief earned a bachelor's and law degree at USF and continued on to practice law in San Francisco for more than 40 years. He left a legacy as the USF law school's most generous donor. The Zief Scholarship endowment, valued at \$9 million, supports 75 second and third-year law students each year. His \$3.2 million gift in 1998 to support the construction of a new library, which he named for his wife Dorraine, represents the largest gift by an individual in the University's history. Not only did he transform the law school with his generosity, but he was also the university's most dedicated and generous supporter. A regular at basketball games, Zief funded scholarships for student athletes and contributed to a renovation of War Memorial Gymnasium. The lobby is now named for his son, Artie Jr. who is developmentally disabled. The Ziefs established the Arthur Zief, Jr. Foundation in 1998. The Foundation has purchased nine homes in San Mateo County where nearly 50 severely developmentally disabled adults now live. Zief was named USF School of Law Alumnus of the Year in 2001.
