

Gloria C. Duffy, Moderator

Gloria Duffy is President and CEO of The Commonwealth Club of California, the nation's largest and oldest public affairs forum, founded in 1903 and headquartered in San Francisco. Dr. Duffy served as Deputy Assistant Secretary of Defense and Special Coordinator for Cooperative Threat Reduction during the first term of the Clinton Administration. She negotiated the denuclearization and dismantlement of weapons of mass destruction in the former Soviet countries of Russia.

Ukraine, Belarus and Kazakhstan, and provided \$1.5 billion in US assistance to those countries. Dr. Duffy holds Ph.D., M.Phil. and M.A. degrees from Columbia University and an A.B. magna cum laude from Occidental College.

Dr. Duffy has founded and headed two international affairs organizations, Global Outlook and the World Forum of Silicon Valley. She is the author/editor of two books, *International Arms Control Issues and Agreements* (Stanford University Press, 1983) and *Compliance and the Future of Arms Control* (Ballinger, 1987). She lives in Santa Clara, California, is married to Rod Diridon, Sr. and has two children, Rod Diridon, Jr. and Mary Diridon.

#### F. Warren Hellman

Warren Hellman is currently a Director of Osterweis Capital Management, Inc.; Sugar Bowl Corporation; D.N. & E. Walter & Co.; Hall Capital Partners, LLC; Advisory Board Member, Rosewood Capital and Shorenstein Properties. Mr. Hellman's civic activities include: Co-Chair, California Commission for Jobs and Economic Growth; Member of the Governor's Council of Economic Advisors; President, Voice of Dance; former



Chairman and current Trustee Emeritus, The San Francisco Foundation; Member, the Committee on JOBS; Member, Board of Directors & Executive Committee, Jewish Community Federation; Chair, Jewish Community Endowment Fund; Member, Advisory Board of the Walter A. Haas School of Business at UC Berkeley; Trustee, UC Berkeley Foundation; Member, Board of Directors of the San Francisco Chamber of Commerce; Member, Board of Directors of the Bay Area Council; Board member, Salesforce.com/foundation; Chair, San Francisco School Alliance Business Advisory Council; Trustee Emeritus of The Brookings Institution; and in 2005 Mr. Hellman was inducted into the American Academy of Arts & Sciences. Mr. Hellman currently lives in San Francisco with his wife Chris and has four children and twelve grandchildren.



#### Laura Scher

Laura Scher is co-founder, chairperson and chief executive officer of Credo Mobile/Working Assets, a company dedicated to building a world that is more just, humane and environmentally sustainable. Ms. Scher co-founded Working Assets in 1985 on the belief that building a business and building a better world are not mutually exclusive. Under Ms. Scher's leadership, the company has donated \$60 million to progressive nonprofit groups such as

Planned Parenthood, Human Rights Watch, Rainforest Action Network and Oxfam America. As CEO, Ms. Scher has helped Working Assets grow to more than \$100 million in annual revenue.



Ms. Scher is a lecturer at Stanford University, teaching "Social Innovation and Entrepreneurship" at the undergraduate level. She has authored chapters in several books, including *The Business of Changing the World* edited by Marc Benioff, and *Hands On! 33 More Things Every Girl Should Know* edited by Suzanne Harper. Ms. Scher serves on the boards of eScrip, SalesForce.com's Foundation, Lightfull Foods, and the Rosenberg Foundation. Ms. Scher gained a Bachelor of Arts degree in economics from Yale and studied international economics at the Institute for International Studies in Geneva. She earned an MBA from Harvard Business School. Ms. Scher lives in the San Francisco Bay Area with her husband, daughter and son.

#### Diane "Dede" Wilsey

Diane "Dede" Wilsey is the President of the Board of Trustees of the Fine Arts Museums of San Francisco, where she chaired the \$200 million campaign to rebuild the de Young Museum, the largest privately-funded cultural gift ever given to the City of San Francisco. In addition, she serves on the Boards of the San Francisco Opera, San Francisco Ballet, and Grace Cathedral, where she also led the capital campaign. As a director of the

ign to build a new

UCSF Hospital Foundation, she is currently leading the campaign to build a new \$1.7 billion Children's, Women's and Cancer Hospital Center at Mission Bay.

Ms. Wilsey was a Coro Fellow in the Women's Public Affairs Training Program. She served as President of the Women's Board of the Presbyterian Hospital, is a trustee emerita of Connecticut College, and was an arbitrator for the Better Business Bureau. In addition to her community and civic commitments, Ms. Wilsey is the owner of the Rutherford River Ranch Vineyards in the Napa Valley, is President of the Wilsey Foundation and is CEO of Wilsey Properties.



#### Akiko Yamazaki

Akiko Yamazaki and her husband, Jerry Yang, co-founder of Yahoo, are active supporters of numerous organizations in the San Francisco Bay Area and beyond. Ms. Yamazaki and her husband co-chaired the \$1 billion Campaign for Undergraduate Education for their alma mater, Stanford University and recently provided the naming gift for the Environment and Energy Building, which is setting the standard for green building and

interdisciplinary research for the entire campus. Ms. Yamazaki is a board member serving on the Executive Committee of the Asian Art Museum in San Francisco and until recently served on the San Francisco Ballet board for over 10 years.

Together with her friend, Charlie Knowles, Ms. Yamazaki co-founded the Wildlife Conservation Network in 2002 which selectively supports entrepreneurial conservationists working in close partnerships with the local community. An avid horsewoman and a competitive rider, Ms. Yamazaki also serves on the National Advisory Committee of the United States Equestrian Team Foundation. Ms. Yamazaki's horse, Ravel ridden by Steffen Peters, represented the US in the Beijing Olympics in 2008.

Ms. Yamazaki and her husband have two young daughters, many equine sons and a Welsh Corgi.

#### Kermit H. Boston

Kermit Boston dedicated his life to service and that is reflected in the many organizations where he dedicated his time and support. He was a member of Grace Cathedral, where he was a Past Chair of the Board of Trustees and was named Trustee Emeritus. He was past Chairman of the KQED Board of Directors, served on the Boards of the Fine Arts Museums of San Francisco and was a founder of the Bay Area Community

Development Corporation and The Western Addition Literary Reading and Discussion Group. He was the Bishop's representative and board member of the Episcopal Senior Communities. Boston's commitment to his community can also be seen by the many organizations and affiliations to whose existence he contributed including: Alpha Phi Alpha Fraternity University, Buchanan Street YMCA-S.F., Grace Cathedral, Elkus Ranch, UC Extension, Black Executives and Exchange Program of the National Urban League.

#### Sue Burns

While many knew Sue Burns as the San Francisco Giants' majority owner and "team mom," she was also a tireless supporter of Sequoia Hospital, serving on the Sequoia Hospital Foundation's board and co-chairing its annual gala for two years. With her late husband Harmon, Sue hosted the Foundation's Wine Auction at her home for eight years and, most recently, served as co-chair of the Foundation's Capital Campaign. Sue inspired the philanthropic spirit in others. Her \$1 million gift in support of the New Sequoia



Hospital, given through the family foundation, echoed her commitment to Sequoia's mission and her care for those around her. In addition to the Sequoia Hospital Foundation, Sue was a dedicated advocate for the Giants Community Foundation, St. Francis Center and St. Pius church. She is survived by her daughters, Tori and Trina, son-in-law Rob Dean, two granddaughters and a great number of family and friends.



#### Anne Chow

Anne Chow, wife of the late William Jack Chow, a prominent San Francisco immigration lawyer, served her beloved city and community in numerous capacities. She was a founder and three times president of the Chinatown Opti-Ms Club, a community organization that provides needed support for many local charities. She was also a founder of the Chinese Hospital Auxiliary and a member of the original committee

and Chair of the Chinese Chamber of Commerce New Year Fashion Show luncheon for 17 years. She served seven years on the Board of Management of the Chinese YWCA including being its Chair and on the San Francisco YWCA Board, and on the board of the Telegraph Hill Neighborhood Association. She was also active in many other civic endeavors. She had been recognized by many organizations, including being named "Outstanding Asian Woman" (1990) and "Mother of the Year" (2000).



#### Luke W. Cole

The Center on Race, Poverty & the Environment (CRPE) founder, Luke W. Cole, passed away in Uganda while on sabbatical on June 6, 2009. Luke founded CRPE almost 20 years ago, in October 1989. What started as the "Luke Cole employment project" has become a 15-person environmental justice organization with a national reputation for representing poor people and people of color fighting for environmental justice.

He is sorely missed at CRPE and he was remembered in their tribute as follows: "Luke was our friend, our mentor and our leader. He inspired us with his warmth, his bravery, and his intolerance for racism, discrimination and injustice. He recognized that an injustice in one community diminishes us all. He shared his power and privilege to help those low income communities and communities of color struggle against powerful interests and buck the status quo. There was a joy and a love inherent in his work, a belief that we all deserve to live a good, healthy, and full life and that communities should speak for themselves."

#### Jean Doyle

Jean Doyle, a mentor to those in the non-profit and foundation worlds and a widely respected civic leader, was instrumental in combining two hospitals resulting in California Pacific Medical Center. She launched the Pacific Presbyterian Medical Center Foundation and helped build its asset base to substantial levels. She helped raise needed funds to re-vitalize the Silicon Valley Community Foundation. Jean championed the idea of philanthropic giving during one's lifetime, and outlined her



vision of a community resource that would partner with those creating a new industry and new wealth in Silicon Valley to work for the benefit of the community. She endowed three academic chairs at Stanford University, generously supported The University of California, Academy of Sciences, Grace Cathedral, Montalvo Center for the Arts, Filoli, and Edgewood Center for Children and Families. In 1999, she established the Bella Vista Foundation, which supports early childhood education and eco-system restoration.



#### Kenneth N. Galloway

Kenneth Galloway, a Wells Fargo Bank trust tax officer and vice president, also served as a special assistant to the president at the University of San Francisco, raising hundreds of millions of dollars to support university programs and enhance financial assistance capability. He was very active as a civic leader in Junior Chamber of Commerce International, Boy Scouts, and UNICEF. He also worked tirelessly to seek philanthropic support for the University of

California and local civic organizations. He received Scouting's Silver Beaver and Antelope and the OA National Distinguished Service awards, for his service at the national and international levels. He and his late wife established the Kenneth and Muriel Galloway Endowment for Athletic Scholarships at the University of San Francisco. He always wanted to feel that his contributions would help to make life better for others.

#### In-Tribute

#### Ruth Levison Halperin

Ruth Levison Halperin, a woman devoted to sharing the wonder of life with those closest to her, was born into the San Francisco family that launched Fireman's Fund insurance. Mrs. Halperin worked for 60-plus years as a volunteer and contributor to Stanford University, her alma mater, and was awarded the 2007 Gold Spike Award, the Stanford Associates' highest award for exceptional volunteer leadership service in development. She



helped build the university's art programs as a trustee and patron. She led the charge to build Stanford's Cantor Arts Center and funded a curatorship there, as well as commissioned the campus' landmark Stone River sculpture. Robert Halperin endowed one of the Cantor Art Center's galleries in his wife's honor. A dedicated donor to the S.F.-based Jewish Community Federation, she also helped found Hillel at Stanford, which was chaired for a time by her husband, Robert Halperin.



#### Collier Carter Kimball

Collier Carter Kimball was active in community service throughout her life, beginning at the home front during WWII and continuing through many volunteer positions, including serving on the boards of Sunny Hills Services, Marin Mental Health Association and the Ploughshares Fund. Always a passionate lover of nature, as well

as an avid hiker and skier, Collier became increasingly concerned about the health of the environment. In her latter decades, she co-founded and served on the board of The Acorn Foundation, a small foundation dedicated to funding grassroots, community-based organizations working for environmental conservation, sustainability and environmental justice. With her then husband, William Kimball, she supported the California Academy of Sciences, as well as many other nonprofit organizations advancing the causes of environmental protection and social justice.

#### Elliot Klein, CFRE

As Associate Director of Development at Stanford University Medical Center's Office of Medical Development, Elliot Klein's work supported the area of Orthopedic Surgery and Sports Medicine. His impressive fund-raising career spanning twenty-nine years also included work for Zeum, the California Arts Council, Opera San Jose, California Council for the Humanities, Lawrence Hall of Science/UC Berkeley, Jewish Family and Children's Services and the Arts Council of San Mateo County. He was recognized as a CFRE (Certified



Fundraising Executive) in 2002. Elliot is fondly remembered by his many friends for his smile, humor, and unflagging optimism. He was a great supporter of the arts and an audiophile. Fluent in French, German, Italian, and always articulate in English, he used language as a window into other people and cultures, maintaining close friendships around the world.



#### Nancy Hicks Maynard

As a journalist and pioneering advocate for diversifying America's newsrooms and astute champion of diversity in news media, Nancy was considered a powerhouse in journalism circles. Her ownership and publishing of the *Oakland Tribune* with her husband from 1983-1992 has identified the *Tribune* as the only major metropolitan daily to have ever been owned by African-Americans.

Nancy and her husband founded the Maynard Institute for Journalism Education in Oakland. She became its president and trained generations of reporters and editors on how to bring people of color into all ranks of the news-making process, and

how to cover stories in such a way that many points of view were included. Following Nancy's first job in 1966 as a copygirl at the *New York Post*, just two years later Nancy became the youngest and first black female reporter at the *New York Times*.

#### Ave Montague

Ave Montague was a noted promoter of arts organizations in San Francisco. She founded the San Francisco Black Film Festival (SFBFF) with little funding, and what began as one day of screenings, grew into an eight day event. The Festival is seen as an important showcase for emerging and risk taking African American filmmakers and highlights an array of works from Brazil, Cuba and Africa. In addition to running the annual San Francisco Black Film Festival,



Montague publicized many nonprofit groups over the years, including the Lorraine Hansberry and Oakland Ensemble theaters, the Bay Area Black Journalists Association, the Omega Boys Club and the Museum of the African Diaspora (MoAD). Montague received the Business Woman of the Year Award from the San Francisco Business and Professional Women's Club in 1994, and, with the late Faith Fancher, was a founding member of Friends of Faith, an organization that educates women about breast cancer.



#### Richard Peterson

Richard Peterson joined the Pacific Gas and Electric Company in 1947 and served as chairman until retiring in 1979. Mr. Peterson took particular pride in actively and meaningfully helping many San Francisco philanthropic institutions, including the new Asian Art Museum, the restored Legion of Honor, the new deYoung Museum, and the wonderfully reconstructed California Academy of Sciences.

Mr. Peterson was also a past president of the Yosemite Fund, and he served for many years on the board of trustees at both Town School for Boys and University High School in San Francisco. He was president and a board member of the American Cancer Society's local chapter. He also served on the boards of the Asian Art Museum, Legal Aid Society, the San Francisco Museum, the San Francisco Planning and Renewal Association, the UC Berkeley Foundation, and the World Affairs Council.

#### Jane Steel

As one of San Francisco's first female stockbrokers, Jane Steel was a pioneer among investment strategists. Jane helped to found the Financial Women's Association of San Francisco for mutual support, seeing the benefit of meeting other successful women focused on similar goals. Her marriage to Marshall Steel, Jr., introduced her to the world of vision research and the impact that funding could make to save and restore sight for so many. In 1995, she established the Jane and Marshall Steel, Jr., Endowment Fund



for Vision Research, which has become known affectionately throughout UCSF Ophthalmology as "The Steel Prize." Valued at over \$2 million, interest earned from the endowment provides the most innovative scientists with the support needed to initiate new efforts aimed at breakthroughs in basic science and translational research. Mrs. Steel also served as a trustee of the Monterey Bay Aquarium.

#### In-Tribute



#### Heidi Ann Strassburger

Heidi Strassburger was dedicated to planned charitable giving, and was a talented and tireless friend and mentor in her field. Prior to serving as the Director of Tax, Legal and Regulatory Affairs at Kaspick & Company, Heidi was Associate Director of Planned Giving at UCSF, where she cultivated gifts and designed and reviewed charitable trust agreements and advised the UCSF foundation on legal and tax issues. Having spent

her last seventeen years of work life in gift planning and advising donors to large nonprofit institutions, Heidi served as immediate Past President, of the Northern California Planned Giving Council. In light of her dedicated work and leadership, the Board of Directors of the Council has established the Heidi Strassburger Master's Lecture Fund in honor of her dedication to, and expertise in, the field of planned charitable giving.

#### Lewis W. Teel

Lewis Woods Teel, VII, "Woody" as he was known, had a huge variety of personal interests and passions. He was a lifelong lover of music, and was on the board of the California Symphony for over 20 years, serving as its Treasurer and President of its Endowment Fund. He adored the theater, and was a major supporter of the Oregon Shakespeare Festival, where the family has made annual trips for 21 years. With his wife, Karen, he founded the Teel Family Foundation, a non-profit dedicated to the support of Theater and Musical Arts,



Health Care, and Education, with a particular emphasis on improving urban education and reducing the achievement gap affecting African-American students. Woody was known for his generosity to family and friends, as he opened his heart and home to one and all.



#### Diane Thomas

Diane Thomas was a lifelong advocate for peace and justice. In 1976, Diane co-founded the UC Nuclear Weapons Lab Conversion Project, toured the state giving speeches with anti-war activist Daniel Ellsberg. Diane, along with Coretta Scott King, was a speaker at a massive rally in June 1982, addressing more than one million people, after she fasted for disarmament for 30 days. Prior

to joining Pacific School of Religion in 2000, Diane served as the executive director of the Ecumenical Peace Institute. Diane also co-founded and strongly supported the Iraq Initiatives Project and the Dismantling Racism Committee at PSR. With her personal faith, her passion for peace and justice, and her capacity for deep relationships, Diane was known as loving and loveable, fully committed and conscientious in her activism, and dedicated to helping make a better life for all people.

#### Gary Tobin

Trained as a city and regional planner at UC Berkeley, Gary Tobin first turned his attention to Jewish communal issues while a professor at Washington University in St. Louis. He then started his own think tank, the Institute for Jewish and Community Research, in San Francisco. His work not only informed understanding of how the Jewish community operates, but also the impact of Jewish philanthropy. He also worked at length with Jewish philanthropists, encouraging them to give more



to Jewish causes and helping them make smart choices about those donations. Through its initiative *B'Chol Lashon* (In Every Tongue), his institute reached out to Jews of color and helped educate the mainstream community about Jewish diversity. The S.F.-based nonprofit created a community of multiethnic Jews and has gone on to educate people across the country about the growing diversity of world Jewry.



#### Daniel Volkmann

Daniel Volkmann practiced architecture from 1952 until he retired from his firm, Bull Field Volkmann Stockwell, in 1991. Mr. Volkmann also spent 39 years collecting a complete first-edition set of California books called the Zamorano 80—a feat accomplished by only three others. He then sold the lot piecemeal. It was that decision that defined what many said was a consummate gentleman, a man who wanted to share his love with many rather than a single person

with a large checkbook. In addition, Mr. Volkmann served as a trustee or director of the San Francisco Museum of Modern Art, San Francisco Conservatory of Music, San Francisco Opera Association, Council of the Bancroft Library at U.C. Berkeley, Town School for Boys, Marin Country Day School, Cypress Lawn Cemetery, San Francisco Art Commission, and the Gleeson Library Associates of USF.

#### Mary Ann Wright

Mary Ann Wright, known as Mother Wright, was a humanitarian activist. Mother to 12 children, she earned a place in the Hall of Fame for Caring Americans for her act of kindness, which began when she used her monthly Social Security check to feed 300 homeless people back in 1980. She started out by serving one meal a week. With help from others, among them grocers, produce merchants, the leaders of local churches and community groups and city officials, this effort grew to become the Mother Mary Ann Wright Foundation, which feeds more than 450 people a day on a budget of \$137,000 a year. The Mary Ann Wright Foundation provides an outreach mission that sends bulk food and clothing to families all across the United States and communities throughout the world. They also give ongoing relief to the Navajo Indian reservations in Arizona as well as poor families throughout Mexico, Africa and Russia, and founded a school in Kenya. In 2005 she was described as "Oakland's 87-year-old version of Mother Teresa... because of her tireless work feeding the hungry."
