





Thank you for joining us for National Philanthropy Day 2019, hosted by the Association of Fundraising Professionals Golden Gate Chapter.



Honorees

Each year the **Association of Fundraising Professionals Golden Gate** marks one day to celebrate the spirit of giving by recognizing exemplars in philanthropy and social change. Awards are presented to individuals and institutions whose giving to the community inspires all of us. They are nominated by the community and selected by a committee of volunteers who are leaders in the world of philanthropy. We are pleased to honor the following 2019 award recipients.

Dolby Laboratories

OUTSTANDING CORPORATE GRANTMAKER



DOLBY

The **Outstanding Corporate Grantmaker Award** recognizes a corporation or its foundation that displays an outstanding commitment to philanthropy not only through its financial support but also by encouraging and motivating others to take leadership roles in philanthropy and community involvement activities.

Through its Dolby Cares initiative, Dolby Laboratories strives to inspire the next generation of innovators in STEAM (science, technology, engineering, art, and mathematics) and address critical community needs in the global communities it calls home.

Dolby is one of the major corporate partners in the mid-Market area of San Francisco, providing support to organizations including 826 Valencia, Women's Audio Mission, Code Tenderloin, Glide, Tenderloin Neighborhood Development Corporation, DeMarillac Academy, St. Anthony's, and Downtown Streets Team.

The company takes a hands-on approach to its philanthropy, developing long-term partnerships that include financial support, volunteerism, in-kind donations, and advocacy.

An example of Dolby's level of support is its involvement with 826 Valencia. With a shared vision of amplifying student voices in the community, Dolby helped the organization formulate its Podcasting Program. In addition to providing annual funding, they designed, installed, and covered the costs to build state-of-the-art recording booths and installed speakers outside the Tenderloin Center so passersby can listen to the voices of the neighborhood's students, learn their stories, and build understanding and empathy. The company also hosted two corporate engagement breakfasts at 826 Valencia, resulting in several new partnerships and connections for the organization. Dolby employees are also committed to 826 Valencia, volunteering in their podcasting program (more than 100 hours!), editing students' podcasts for broadcast, providing human resources counsel, and serving as inaugural members of the organization's Associate Board.

Now that's what we call support!

American Muslim Fund

OUTSTANDING FOUNDATION OR GRANTMAKING ORGANIZATION

Founded in 2016, the American Muslim Fund is a national, grassroots community foundation in the United States. Its focus is on creating Donor Advised Funds and Giving Circles, distributing grants, and building endowments for the Muslim community. In the last two years it has granted over \$1 million to 115 nonprofit organizations.

Projects include disaster or humanitarian relief and support for food banks and domestic-violence shelters. A third of the foundation's donor-advised funds are in the Bay Area. One of its local recipients, the Council on American-Islamic Relations, focuses on protecting the civil liberties of the American Muslim community, for example. Another grantee was supported in her research on mental health at Stanford University.

Among over 750 community foundations in the United States, AMF is the first to focus on building an ecosystem of Muslim philanthropy to connect nonprofits and donors. The Fund is attracting younger donors and strives to showcase Muslim generosity. Through its partnership with secular organizations in local communities, it hopes to demarginalize the Muslim community. In a very short time, it has proved itself to be a scalable model.

Led by Co-Founder and Director Muhi Khwaja, the Foundation's vision is to lead sacred, sustainable, and strategic Muslim philanthropy for today and future generations.



The **Outstanding Foundation or Grantmaking Organization Award**

recognizes a private or community foundation or community grantmaking organization that provides financial support, inspiration, encouragement, and motivation to nonprofits and grantmakers alike—as well as developing innovative approaches to philanthropy.

Hannah Kahn, Vice President of Grants Management, Arnold Ventures

OUTSTANDING FOUNDATION PROFESSIONAL



The **Outstanding Foundation or Grantmaking Professional Award** honors a foundation or grantmaking professional who individually initiates or supports creative nonprofit efforts and works to develop philanthropic partnerships with organizations and communities in an exceptionally effective or unique way.

Hannah Kahn is an operations professional with more than 10 years of experience. Her expertise is in hybrid LLC philanthropy operations, with a special focus on technology systems for scale. She is currently Vice President of Grants Management with Arnold Ventures, where she built a new grants management function, hired a team of five, and has begun to implement its grants-management strategy and revamped technology to support data-driven philanthropy.

She has also held positions in this specialty at the William and Flora Hewlett Foundation and at Adobe Foundation. After her years there, she became the first director of grants management for the Chan Zuckerberg Initiative. There, her team managed more than \$500 million in annual giving.

Hannah's passion for philanthropy extends to her volunteerism on the boards of other nonprofits whose missions of community-building she values: She is secretary of the board at Outdoor Afro, a national nonprofit organization based in Oakland that has inspired black leadership to encourage people of color in their outdoor appreciation of nature. The organization now has 80 leaders in 30 states. As a volunteer board member, Hannah has been responsible for bringing in more than \$500,000 in unrestricted funds to the organization.

And at Creativity Explored, a visual-arts studio in San Francisco's Mission district, Hannah has supported (for over a decade) the work of artists with developmental disabilities by lending her expertise in fundraising and recruiting new members to its board. Hers is a rare combination of both strategic and operational expertise applied to her many passions for the common good.

Child Care Law Center

VINEYARDS AWARD

Good affordable child care creates opportunities for children, families, and communities. But for most families, finding child care feels like winning the lottery—our state hasn't developed enough licensed care, and many parents can't afford the cost. Without child care, parents can't work to support their families, and kids miss out on important early learning and social development.

The Child Care Law Center advocates, educates, and when necessary litigates, to remove the barriers standing between families in need, and good, affordable child care.

The Law Center attorneys have used their legal and policy expertise to:

- Win millions of dollars in new funding so more low-income families have quality, affordable care
- Make sure children with health issues like diabetes or epilepsy are included in child care and preschool and can get their medicines there
- Help dozens of child care programs open or expand, empowering local organizations with tools to advocate with city and state government

In one of their most significant cases, the Law Center went to court on behalf of 55,000 families after Governor Schwarzenegger vetoed their child care funding in 2010. "The Child Care Law Center represented me, so I could keep my affordable child care—and then they taught me how to advocate to improve the program for all parents," said Francis, one client.

Partnerships with parents and child care providers make the Law Center stand out as a small, but driven team dedicated to making good quality child care available and affordable to everyone.

Hollis Belger

OUTSTANDING YOUTH IN PHILANTHROPY



The **Outstanding Youth in Philanthropy Award** recognizes service by an individual or group of young people ages 5 to 17 (at the time they are nominated) who demonstrate outstanding commitment to the community through direct financial support, development of charitable programs, volunteering, and leadership in philanthropy.

Hollis Belger embraced a cause at a young age. At nine, as a young soccer player, she founded Juggling for Jude to support the work of St. Jude Children’s Research Hospital. Five years later, she has raised an astonishing \$400,000—all by juggling her soccer ball for donations. She also writes blogs, sends newsletters, speaks to media, and contacts corporations for support.

Directors at St. Jude highlight Hollis’s initiative, creativity, and follow-through as exceptional among donors of any age. With her unique approach, she has raised more funding in support of hospital operations than many anticipated and has made countless friends with St. Jude patients, parents, and staff.

Hollis’s commitment extends beyond St. Jude. She gives presentations at Bay Area schools and throughout the country, raising awareness about pediatric cancer and the role youth can play in philanthropy. A charismatic speaker, she inspires entire school communities to raise money for a cause.

Hollis’s juggling and fundraising have captured the attention of elite soccer players, from Mia Hamm to Kelley O’Hara. In 2018, Hollis was honored as US Soccer’s 2018 “She Believes Hero.” At age 12, she won the Jerry Nicholson Young Fundraiser award at St. Jude, she was the St. Jude Ambassador at the 2018 San Francisco Miracles on the Bay gala, and she was recognized in 2018 as a state finalist in Prudential’s Spirit of Community awards. Leading by example, Hollis’s empathy is contagious, reminding us that small acts of kindness can have significant repercussions in the lives of others.

Diane Goodhue

OUTSTANDING FUNDRAISING VOLUNTEER

For the past 40 years, Diane Goodhue has committed her time to providing leadership and philanthropy for local organizations dedicated to enhancing the quality of life for Oakland children and families. Early in her career she was a teacher of developmentally challenged Oakland Unified School District elementary students before turning to fulltime involvement with Goodhue Investments.

Diane's non-profit board involvement has included Lawrence Hall of Science Advisory Board, Oakland Children's Hospital Branches Board, Oakland Symphony League, Bellevue Club, and Lincoln Child Center, to name a few.

Diane was inspired by her parents, Mario and Erma Delucchi, who, among other generous acts, sponsored Fairyland's original Pinocchio set in the early 1950s as part of an Italian American Federation of the East Bay project. More than 60 years later, Diane and Neil Goodhue funded the set's restoration in her parents' honor. Diane agreed to co-chair Fairyland's annual gala in 2018 and served as co-chair again this year. Besides providing inspired leadership, she made her own significant monetary and in-kind contributions and encouraged others to do the same. The Goodhues also helped make the veterinary medical hospital at the Oakland Zoo a reality with a generous gift to its capital campaign.

Diane has received the "James Mann Award" from Lincoln Child Center for her extraordinary community service and support of families in Alameda and Contra Costa counties and was chosen several years ago by then Oakland Mayor Ron Dellums as a "Woman of Greatness"—one of 11 chosen in the four Bay Area counties.

Diane is most excited about becoming a grandmother with the arrival of her grandson, Locke David Goodhue, on June 17, 2019.



The **Outstanding Fundraising Volunteer Award** is presented to an individual who has demonstrated exceptional leadership skills in coordinating groups of volunteers at more than one nonprofit for major fundraising projects that benefit charitable institutions and show a commitment to the advancement of philanthropy.

HANK ROSSO OUTSTANDING PROFESSIONAL AWARD



The **Hank Rosso Outstanding Fundraising Professional Award** honors an individual fundraising professional who practices his or her profession in an exemplary manner.

Sandy Drew is an independent consultant working with nonprofits on board governance and development issues. From 1999 to 2015 she served as a consultant with Marts & Lundy and co-leader of the firm's Schools Practice Group.

Prior to her consulting work, Sandy served as director of development at Lick-Wilmerding High School in San Francisco. In 1998, she co-founded the California Schools Development Conference (CAPS) to specifically address the need for professional opportunities for development teams.

Earlier in her career, Sandy served as the director of development at KQED, San Francisco's public broadcasting television and radio station. Before moving to the Bay Area in 1989, she lived for 20 years in Denver, Colorado, where she served as director of development for several educational and civic organizations.

In addition to her professional activities, Sandy serves as a class agent for Mt. Holyoke College, is a past board member of the Golden Gate Chapter of the Association of Fundraising Professionals, Live Oak School, St. Paul's Episcopal School, The Bay School of San Francisco, and the Oxbow School. She also is a founding board member of Leadership and Design. Currently, Sandy serves as a director at Teen Services Sonoma and Pets Lifeline Sonoma. She also tutors in the Sonoma County Adult Literacy Program and volunteers for Friends in Sonoma Helping and Impact 100. Clearly, giving of herself is part of Sandy's DNA.

Jerry Yang and Akiko Yamazaki

OUTSTANDING PHILANTHROPISTS

For the past 25 years, Jerry Yang and Akiko Yamazaki have been two of the Bay Area's leading philanthropists in the areas of higher education, art and culture, and conservation. Jerry cofounded Yahoo! in 1994 (serving as its CEO from 2007 – 2009) and AME Cloud Ventures in 2012 to invest in and mentor technology startups. He is vice-chair of Stanford University's Board of Trustees.

Jerry and Akiko have contributed significantly to Stanford University, their alma mater. They served as co-chairs of the University's \$1 billion Campaign for Undergraduate Education. The Jerry Yang and Akiko Yamazaki Environment and Energy Building is the first of four buildings that the University has dedicated to multidisciplinary research and the first to receive Platinum LEED certification. Both Jerry and Akiko serve on the advisory board of the Cantor Center for Visual Arts.

Akiko has served as a trustee, commissioner, and board chair at the San Francisco Asian Art Museum. Under her leadership, the museum's "For All" Campaign has raised more than \$100 million towards renovation and expansion. A new, special exhibitions pavilion, scheduled to open in 2020, will be named in the couple's honor. Akiko also cofounded the Wildlife Conservation Network in 2002. To date, the organization has raised more than \$120 million to support the work of conservationists around the world.

Jerry and Akiko have shared their art collections at various museums, including their Chinese Contemporary Ink Painting collection at the Cantor's "Ink World" exhibition and Jerry's extensive Chinese Calligraphy collection at the Asian Art Museum in San Francisco and the Metropolitan Museum of Art of New York City.



The **Outstanding Philanthropist Award** is presented to an individual or family with a record of exceptional generosity who, through direct financial support, has demonstrated outstanding civic and charitable responsibility and who encourages others to take philanthropic leadership roles in their communities.

Mal Warwick

LIFETIME ACHIEVEMENT



The **Lifetime Achievement Award** honors an individual or family with a proven lifetime record of exceptional generosity who, through direct financial support, demonstrates outstanding civic and charitable responsibility and whose generosity encourages others to take philanthropic leadership roles in the community.

Fundraising Thought Leader. Over the course of four decades, Mal Warwick has helped tens of thousands of professionals master the techniques of successful fundraising—as the author of 17 books, editor and publisher of a long-running newsletter, consultant to hundreds of nonprofit organizations, popular speaker at fundraising conferences throughout the world, and as a mentor to many.

Through his agency, Mal and his colleagues have pioneered new fundraising techniques, elevating direct mail, telemarketing, and online fundraising into the realm of major gift and legacy fundraising. Together, they have raised a total of more than \$1 billion, largely in small gifts.

Mal's 17 books include *Revolution in the Mailbox*, which has helped shape the thinking of thousands of development professionals who have taken the CFRE exam, and the bestseller *How to Write Successful Fundraising Appeals*, widely recognized as the standard text in the field.

Mal Warwick has served the world of fundraising in numerous other ways as well: as board member, volunteer, and donor. He has chaired the boards of the Bay Area Book Festival, GreatNonprofits, Berkeley Community Fund, and Social Venture Network, and served as a director of the Fistula Foundation, READ Global, the National Peace Corps Association, and the Berkeley Symphony. And he formed and for several years chaired the direct-marketing track at AFP's international conferences.

Mal founded his company in 1979. Now called Mal Warwick Donordigital (Berkeley and Washington, D.C.), the firm is a B Corporation and is employee-owned.

In 2004, Mal received the Hank Rosso Award as Outstanding Fundraising Executive. And in 2009 he was granted the Max L. Hart Nonprofit Leadership Award by the Direct Marketing Association Nonprofit Federation in recognition of his lifetime contributions to the field.

James C. Hormel

LIFETIME ACHIEVEMENT

James C. Hormel has dedicated his life to the advocacy of human rights, social justice, and the well-being of all individuals.

Hormel graduated from Swarthmore College. Among his many formidable contributions to the institution, he funded a faculty chair in social justice, and alongside his spouse, Michael P. Nguyen (also an alumnus), recently established a new facility for the Intercultural Center. He received his J.D. from the University of Chicago Law School, where he subsequently was Assistant Dean and Dean of Students. He is a life member of the Visiting Committee of the Law School. In 1986, he sponsored the Hormel Public Service program at the Law School.

Hormel served as United States Ambassador to Luxembourg from June 1999 to December 2000. He was alternate representative of the U.S. delegation to the 51st United Nations General Assembly in 1996 and was a member of the U.S. delegation to the 51st U.N. Human Rights Commission in 1995.

For more than 30 years, Hormel has been instrumental in developing resources for organizations serving people affected by HIV and AIDS, substance abuse, and breast cancer. He was a founder of the Human Rights Campaign, the largest national LGBT advocacy organization, and served as a member of the board of directors of The American Foundation for AIDS Research.

He currently serves on the boards of People For the American Way and The Commonwealth Club of California, and is a life member of the Board of Governors of the San Francisco Symphony, Trustee Emeritus of The San Francisco Foundation, and Manager Emeritus of Swarthmore College.

Hormel has five children, fourteen grandchildren, and seven great-grandchildren. He and Michael reside in San Francisco.

HONOREE: **Erin C. Badillo**

Erin is executive director of Dress for Success San Francisco and San Jose. She is the organization's second ED and is focused on growing fundraising and establishing strong institutional procedures as the company heads into its fifteenth year. Prior to Dress for Success, Erin was executive director for the Lupus Foundation of Northern California and a regional development manager for the Arthritis Foundation. She is a member of Junior League of San Francisco and the Metropolitan Club.



HONOREE: **Victoria Barret**

SPONSOR: **Bay Area Discovery Museum**

Victoria Barret has had a tremendous impact on the Bay Area Discovery Museum, where she served on the board from 2012 to 2019. Under her leadership as chair from 2016 to 2019, a member of the CEO search committee, and campaign chair, BADM increased its annual revenues by 50% and raised over \$16.5 million toward its first capital campaign in over a decade. Victoria is a champion for and believer in the museum's mission and is a thoughtful and talented leader and fundraiser. Her Bay Area commitment extends beyond the museum; she recently joined the board of trustees at Town School for Boys.



HONOREE: **BlackRock**

SPONSOR: **San Francisco-Marin Food Bank**

BlackRock has partnered with the San Francisco-Marin Food Bank since 2008 and is a leading example of corporate partnership in the fight against hunger. The organization believes that financial security is key to long-term well-being but remains out of reach for many and seeks to help people living on low incomes build financial security. With BlackRock's generous contributions of time, energy, and funding, the lives of our most vulnerable neighbors can be transformed through food and advocacy. BlackRock funding has enabled the Food Bank to provide over 2.4 million meals, and employee volunteers have contributed over 5,300 hours of service.



HONOREE: Jane Davis

SPONSOR: La Casa de las Madres

Jane Davis has lived in the Bay Area since 2007, after stints in Minnesota, Portland, Chicago, and Ann Arbor. She and her family run the Davis Family Foundation, which is dedicated to supporting organizations that provide practical support to at-risk populations—from refugees to survivors of domestic violence. In Tribute

We remember the donors, volunteers, and nonprofit and foundation staff who passed away between **September 1, 2018 and August 31, 2019**. The following individuals represent the many who contributed throughout their lifetimes to the Bay Area philanthropic community. These individuals truly did change the world with their giving hearts.



Ernest "Chuck" Ayala 1924 – 2019

Native San Franciscan Ernest Ayala accomplished much in his long life. He was a veteran of WW II, a Realtor, a small business owner, and a community advocate—born into an immigrant family of nine children. After earning undergraduate and graduate degrees at California universities, he operated Ayala Real Estate & Insurance on Castro Street for over 50 years. He founded Centro Latino de San Francisco in the Mission District in 1973 and went on to serve on the California Commission on Aging and the White House Conference on Aging and as director of urban development for the Catholic Youth Organization, receiving the Dolores M. Huerta Lifetime Achievement Award from Mayor Ed Lee, among many other honors.



Paul "Pete" Bancroft, III 1930 – 2019

Paul "Pete" Bancroft was the great-grandson of noted historian of the American West Hubert Howe Bancroft. Pete took particular pride in Howe's use of oral histories to preserve the diverse voices of the early West, from native peoples to new settlers. A pioneer himself in the venture-capital industry, Pete sponsored oral histories of other leaders in that field. Over time, he and his family contributed to numerous projects of The Bancroft Library at the University of California, helping to fund endowments that provide long-term support for the Oral History Center and the Western Americana Program at the Library. Pete will always be remembered as a wonderful supporter and friend of the Library.



James T. Bill 1937 - 2019

James "Jim" Bill was a stalwart and generous friend to the people and institutions he cared about. As a tireless volunteer and philanthropic leader, he believed in giving back and then giving some more. Jim was deeply invested in the long-term support of Bishop O'Dowd High School, where he graduated from the first class in 1955; and later established two endowment funds for scholarships which he then continued to support throughout his life. He was particularly admired for giving in a way that would encourage support from the broader alumni community while shunning the spotlight. Jim was equally dedicated to St. Patrick's Seminary in Menlo Park, where he also studied.



Jan Blum 1938 – 2019

Jan Blum was a stalwart advocate for public open space in San Francisco. As the Presidio transitioned from post to park, she served on the Presidio Environmental Council, the Restoration Advisory Board, and People for the Parks/ Presidio. As a volunteer, she planted to help restore the shoreline dunes and tidal marsh during the transformation of Crissy Field. Jan was a tireless leader and advocate for converting an abandoned and derelict City reservoir into Francisco Park, serving on the board of the Francisco Park Conservancy. Unselfishly and without accolade, she helped create a healthier, more beautiful and inclusive City for all through her generous philanthropy and tireless service.



Paul Crane Dorfman 1939 – 2018

Longtime philanthropist Paul Crane Dorfman believed in serving others, and throughout his life he dedicated his personal resources and shared his wisdom with many organizations. As executive vice president of the San Francisco Opera, he enjoyed raising funds for the artform, navigating strategic challenges, and helping to select the new general director to steward the organization for the future. He served as president of The Japan Society, on the boards of Jewish Family and Children’s Services, the American Jewish Committee, and the Pacific Council on International Policy, and was a trustee for the World Affairs Council. Along with his wife, Valerie, he was a member of both Temple Emanuel and Grace Cathedral.



Phyllis Friedman 1923 – 2019

Phyllis Friedman is remembered for her love of people—her recognition of the best in everyone—and for her ability to inspire human caring and giving in her community. With undergraduate and graduate degrees from the University of California at Berkeley, she launched a career in social work, focused on helping Russian emigres and single, teenage mothers. She had an unwavering dedication to social justice. Along with her husband, Howard, she was deeply committed to the work of the ACLU while supporting a multitude of other causes. She celebrated the nonprofits and their leaders who accomplished the “essential work” that others funded.



William "Bill" Godward 1913 – 2019

Bill Godward found his passion for the arts early in life. After many years as an opera-season ticket holder, he went on to serve on the boards of the Chamber Music Society, Spring Opera (where he also served as president), and San Francisco Opera. President at SF Opera from 1995 to 2002, he was instrumental in facilitating renovations to the War Memorial Opera House and deepening engagement by board members. To honor Bill's profound belief in the need to reach new audiences, the SF Opera established the Bill Godward Audience Development Fund in his honor in 2002.



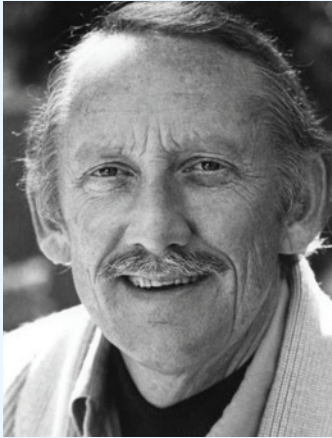
Sydney Goldstein 1944 – 2018

Sydney launched the pioneering nonprofit City Arts & Lectures in 1980, presenting on-stage talks between notable figures and interviewers. Today, those conversations are broadcast on more than 130 public radio stations nationwide, and the recordings are archived at UC Berkeley's Bancroft Library. The program's "On Arts" series benefits 826 Valencia college scholarships and has helped send 50 students to college since its inception in 2004. In 2018, 826 Valencia named one of the scholarships in Sydney's honor. Other notable nonprofits that have benefited from the program's events are Prison University Project, Equal Justice Initiative, NRDC, the Women's Foundation, and Friends of the Public Library.



Ellen Taylor Huppert 1936 – 2018

Ellen Taylor Huppert channeled her interests in history and education into multiple civic enterprises. After teaching at San Francisco State University and Holy Names College, Oakland, she continued her career as an independent scholar. In the same period, she helped found the San Francisco Parents' Lobby in the wake of funding cuts to public education. From 1981 to 1995, Ellen served on the board of the San Francisco Education Fund, and also for a period as its interim executive director. In 1993, she joined the board of directors of the Friends of the San Francisco Public Library, and her decade of participation included chairing the board during the campaign to build the new Main Library.



Joseph William Knowland 1930 – 2019

The award-winning editor-in-chief and last independent publisher of the Oakland Tribune, Joseph Knowland had a passion for performing. The life-long East Bay resident was also dedicated to his community. Joseph brought this passion and commitment together when he and his wife, Dee, cochaired the fundraising campaign to restore Oakland's Art Deco masterpiece, the Paramount Theater. (The building has been designated a National Historic Landmark.) A much sought-after leader, Joseph also served on the boards of Mills College and the California College of Arts and Crafts, both of Oakland, as well as on volunteer committees of the Commonwealth Club San Francisco.



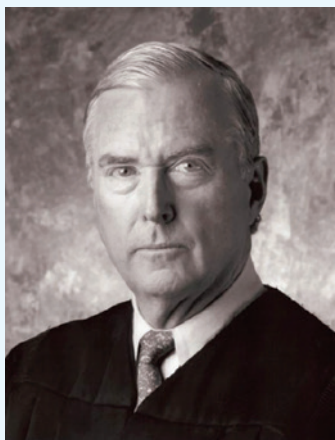
Kathryn Lew Lowe 1936 – 2019

Kathy partnered with her husband, Rolland, as he tirelessly crusaded for the Chinese American community, the medical profession and health services, and philanthropic engagement. The Lowes were benefactors of Asian Health Services in Oakland, which named one of its buildings for them. A stone bridge in San Francisco Chinatown's Portsmouth Square also is named for the couple in recognition of their support of the Chinese Culture Foundation and other organizations. Kathy was an outspoken champion for social justice and was active in Chinese for Affirmative Action, Chinese Hospital Auxiliary, and Square and Circle Club. She also was the recipient of a Lifetime Achievement Award from the Chinese Newcomers Service Center.



Peter A. Magowan 1942 – 2019

A Safeway CEO and an owner of the World Series Championship San Francisco Giants, Peter Magowan is credited with saving the team from relocating to Florida by spearheading a charge to build a new South-of-Market waterfront ballpark. He also cared deeply for people with developmental disabilities and determined to include them in the workforce, changing many lives. Under Mr. Magowan's leadership, the Giants Community Fund developed the Junior Giants, a free baseball and life-skills program that annually serves more than 20,000 at-risk kids. In 1994 the Giants famously inaugurated "Until There's a Cure Day," becoming the nation's first professional sports team to raise funds and awareness in the fight against HIV/AIDS.



William A. Newsom III 1934 – 2018

Judge Newsom, a retired justice of the California Court of Appeal and father of California Governor Gavin Newsom, was a staunch advocate of the environment. He served on the boards of the Sierra Club Foundation, Earthjustice, Environmental Defense Fund, Friends of the River, Sierra Watch, and the Mountain Lion Foundation. Bill was a visionary conservationist from an early age, avidly supporting dozens of individuals and organizations working to protect our public resources: clean air, clean water, biodiversity, wildlife and wild places, especially our forests, as well as rivers and oceans. He also served on the board of regents of the University of Santa Clara and the board of directors of the International Bioethics Institute and as a grantmaker at the Getty Foundation.



Suno Kay Osterweis 1943 – 2018

Suno Kay Osterweis was known for her dedication to Asian art and to the Asian Art Museum, where she served as a trustee for 29 years. With a Master's degree in East Asian Studies from Stanford and her fluency in multiple languages, she brought both her expertise and her generosity to help build the current Asian Art Museum and support its collections and activities. "Suno's enthusiasm for the Asian Art Museum inspires all of us, and her warm encouragement helped to nourish and sustain me as a leader," noted Asian Art Museum director Jay Xu, "I miss her terribly and will treasure her memory forever."



Elizabeth Caspers Peters 1926 – 2019

Elizabeth Peters was a formidable fundraiser—tireless and profoundly effective—on the boards where she served. She was on the board of California Pacific Medical Center as an early champion of alternative modalities for cancer patients for three decades and was a board member for 15 years at the San Francisco Symphony, ultimately becoming a Life Governor. She was also an active member of the Alumni Board at her alma mater, Stanford University. Elizabeth said that her work was "a way to express my gratitude to a city that has been so good to me. It's a true joy to help build something that will have such a positive impact."



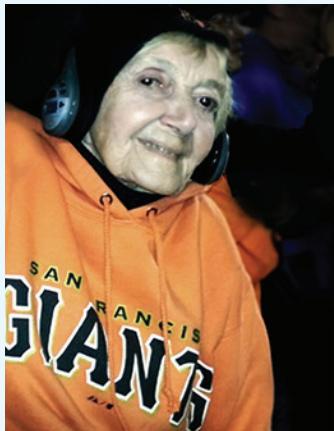
Nita Reifschneider Spangler 1923 – 2019

Nita Spangler leaves a significant legacy as a San Mateo County journalist, volunteer, activist, historic preservationist, and conservationist. She founded the Portolá Expedition Bicentennial Foundation in 1966 and convinced the San Mateo County Supervisors to purchase the Sweeney Ridge discovery site as a National Historic Landmark. She chaired the San Mateo County Scenic Roads Committee for a decade, and served on the San Mateo County Parks and Recreation Commission from 1983 to 1997. Nita also helped to preserve the Sanchez Adobe, Tripp Store, and other Bay Area historic sites. She was instrumental in the campaigns to save Bair Island and to establish Edgewood Park and Natural Preserve in Redwood City.



Frank Stein 1927 – 2019

Frank is remembered as a role model of selfless generosity. When he was diagnosed with glaucoma, he and his life partner, Paul May, funded the Pacific Vision Foundation to support treatment for others suffering from this condition. They generously funded the Glaucoma Research Foundation and established both the Low Vision Center and the Interventional Endoscopy Center in their names at the California Pacific Medical Center. Other recipients of Frank's generosity were Pancreatic Cancer Research at the University of California San Francisco, Chabad's Residential Treatment Center for Substance Abuse, Jewish Home for the Aged, and Parents Place at Jewish Family and Children's Services, San Francisco.



Dorothy Mae Walker (Boardman) 1936 – 2018

Dorothy was a strong, self-reliant, smart, and enthusiastic woman who contributed broadly to her beloved San Francisco. She gave generously to LightHouse for the Blind, The Salvation Army, and La Casa de las Madres. Dorothy also volunteered as an usher for the San Francisco Opera, San Francisco Symphony, and San Francisco Ballet. She devoted her time to the de Young and Legion of Honor Museums and the San Francisco Botanical Gardens for over 20 years and demonstrated her historical knowledge of San Francisco as a docent for the Haas-Lilienthal House. An avid golfer, she also enjoyed travels around the world, but always relished coming home.



Kirby Walker 1956 – 2019

Kirby Walker will be remembered for her philanthropy and activism. She was also a documentary filmmaker. Her most recent film, *Toxic Hot Seat*, prompted a change in California law to protect consumers from carcinogens in flame-retardant fabrics. She was honored with the San Francisco Firefighters' "White Helmet" award for the film's contribution to the health and welfare of firefighters. Kirby served on the boards of the Natural Resources Defense Council, Marin Country Day School, Summer Search, and the Redford Center. Her philanthropic and volunteer leadership also included Global Fund for Women, Marin Agricultural Land Trust, KIPP Bay Area Schools, California Academy of Sciences, the Pacific Forest Trust, and the Golden Gate National Parks Conservancy.



Pegi Young 1952 – 2018

A champion of children with severe physical and speech impairments, Pegi Young co-founded the internationally recognized Bridge School with her ex-husband, Neil Young. Under her leadership, the school developed innovative approaches to education and communication through assistive technology. Now an online middle and high school program, it has fostered the way to a life without barriers to education, inclusion, and communication for children the world over. Pegi's passion for art and music led her to support other organizations dedicated to enriching children's lives through creative expression. She expressed her own love for nature and the environment through conservation initiatives such as the effort to protect the Amazon rainforest.

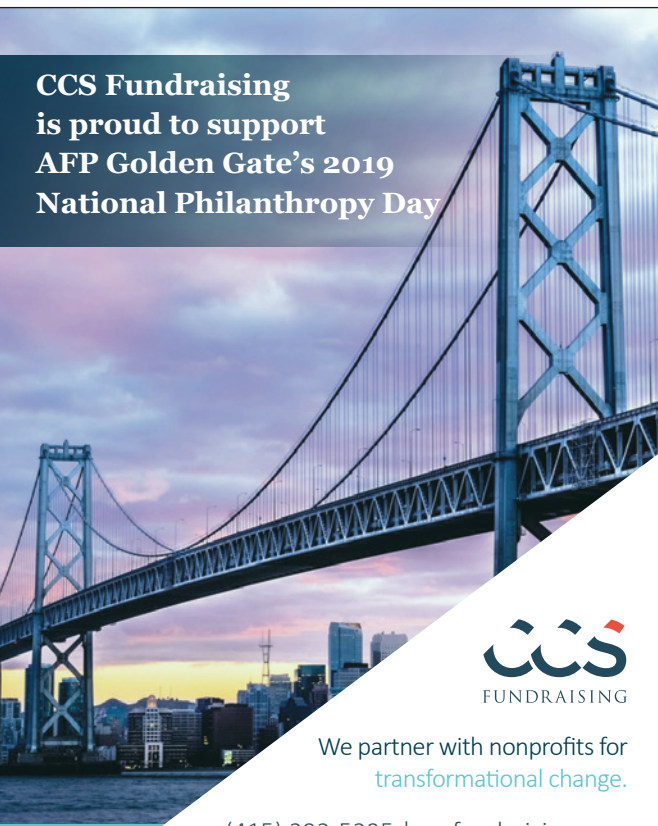

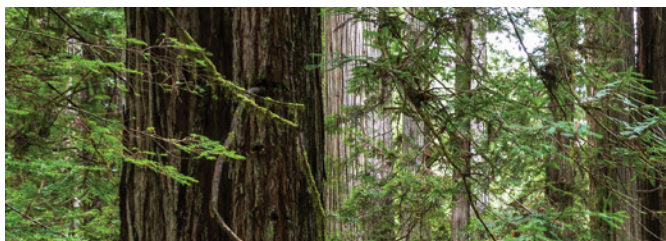
