Michael Krasny, PhD

MASTER OF CEREMONIES

Michael Krasny, PhD, has been in broadcast journalism since 1983. He was with ABC in both radio and television and migrated to public broadcasting in 1993. He has been Professor of English at San Francisco State University and also taught at Stanford, the University of San Francisco and the University of California, as well as in the Fulbright International Institutes. A veteran interviewer for the nationally broadcast City Arts and Lectures, he is the author of a number of books, including Off Mike: A Memoir of Talk Radio and Literary Life (Stanford University Press); Spiritual Envy (New World); Sound Ideas (with M.E. Sokolik/ McGraw-Hill); and Let There Be Laughter: A Treasury of Great Jewish Humor and What It All Means (Harper-Collins) as well as the twenty-four lecture series in DVD, audio and book, "Short Story Masterpieces" (The Teaching Company). He has interviewed many of the world's leading political, cultural, literary, science and technology figures, as well as major figures from the world of entertainment. He is the recipient of several awards for his broadcasting, writing and scholarship, including, most recently, a Silver SPUR Lifetime Achievement Award, the most prominent award for lifetime civic achievement in San Francisco, and a 2020 Simpsonista Prize for enabling writers and writing, and readers and reading across generations. He has also been awarded the S.Y. Agnon Medal for Intellectual Achievement; The Eugene Block Award for Human Rights Journalism; the James Madison Freedom of Information Award; the Excellence in Journalism Award from the National Lesbian and Gay Journalists Association; Career Achievement Award from the Society of Professional Journalists and an award from the Radio and Television News Directors Association. He holds a B.A. (cum laude) and M.A. from Ohio University and a PhD from the University of Wisconsin.

Philanthropy Across Our Diverse Bay Area Communities

New data recently released by the US Census Bureau from last year's 2020 Census confirms what many were already speculating: racial and enthic diversity has continued to increase across the United States over the past decade and particularly in California, the most populous state in the nation.

California's white population fell by 24% between 2010 and 2020 while California's Asian population grew by 25% to 6 million people. Hispanics surpassed whites as California's largest ethnic group, growing by 11% to 15.5 million, just shy of 40% of the state's nearly 40 million residents. California has the highest Native American population in the country with 1.4 million residents representing 3.5% of the state's population.

What are the implications of increasing diversity across our communities for philanthropy? This year's Philanthropy Forum brings together a diverse group of volunteer fundraisers, philanthropists and civic leaders to explore how philanthropy and fundraising are practiced across the diverse communities of the Bay Area.

is the immediate past president of the Board of Port Commissioners and is the founder of Horizon Beverage Company, an Oaklandbased beverage distributorship. Ces sold his business in 2015 and funded his charitable foundation - the "CesTRA Butner Family Foundation." The foundation is dedicated to funding educational efforts and opportunities for underserved African American and Hispanic youth in Oakland.



David Lei sold his consumer products sourcing company in 2003 and retired. In retirement David remains active in nonprofit work, with a focus on developing sustainable funding models for community-based organizations. He is currently the board chair of the Chinese Performing Arts Foundation and vice chair of the Chinese American Community Foundation.



Sara Lomelin

is the founding executive director of Philanthropy Together, a global initiative to diversify and democratize philanthropy through the power of giving circles. Prior to Philanthropy Together, Sara served as Senior Director of Leadership Philanthropy at Accion Opportunity Fund, and as VP of Philanthropy at the Latino **Community Foundation** where she created the Latino Giving Circle Network.™



Greg Sarris is the Chairman of the Federated Indians of Graton Rancheria and President of the Tribe's Economic Development Board, overseeing all of the Tribe's business interests, including the Graton Resort and Casino. An educator and award winning author, his collection of short stories Grand Avenue was adapted into an HBO miniseries which he co-executive produced with Robert Redford. Currently he is executive producing the documentary bio on Joan Baez.

HANK ROSSO OUTSTANDING FUNDRAISING PROFESSIONAL

Georgi Kelly is KQED's Vice President, Development. She leads Major, Planned, and Foundation giving, and has led KQED's Campaign 21, raising more than \$139M to transform KQED's programs and renovate their headquarters. She also leads fundraising partnerships with NPR and PBS.

Kelly joined KQED in April 2001 as Director of Signal Society. In 2004, she launched the Producer's Circle, a new donor club for members giving \$10,000 or more; and, in 2008, when Signal Society and Producer's Circle were combined into one team, she was named Sr. Director of Leadership Gifts. Georgi celebrated her 20th anniversary at KQED this past spring and says that she'd like to see more early and mid-career fundraisers stay at organizations for longer terms (maybe not twenty, but how about more than 2.5?) Our work is relationship-centered and she feels that her long tenure at KQED has contributed to her success and also has enriched her!

Prior to KQED, Georgi held progressively responsible and leadership positions in development at Big Brothers-Big Sisters, Raphael House shelter for homeless families, San Francisco Education Fund, Boys & Girls Clubs of San Francisco, and Charitableway. Kelly has been a long-time member of AFP Golden Gate and served as a member of the Board.

Georgi is a fourth-generation Oregonian but has called the great state of California home for more than 30 years. She lives in San Francisco with her husband of over 27 years and is a proud mom to her 19-year-old son who is a student at Syracuse University.

Amador Valley High School Student Leadership Committee

OUTSTANDING YOUTH IN PHILANTHROPY

Here at Mr. Amador, we are driven by a single goal: to raise funds for the families utilizing the George Marks Children's House as a home away from home. Without donations, the House would not be able to provide services in our community. This pediatric palliative care center allows for terminally ill children to be surrounded by their friends and families in a homely environment where there is still the necessary medical equipment the child needs to survive. Our goal is to give these families peace and the opportunity to embrace their time together. All the money we raise is donated to the House and there are no overhead costs. We are proud to have supported this organization for the past eight years and to have raised hundreds of thousands of dollars. Each year, ten of Amador Valley High School's most upstanding men are chosen to participate in our year-long community outreach program, and over the past 16 years since the program's creation, it has become the school's favorite time of the year. The boys as well as over 40 committee members are hard at work from November through April, planning fundraisers, organizing events, and partnering with other local student groups, as well as having fun with the school through funny lunchtime dances or in-class surprises. The Mr. Amador program continues to not only benefit the House, but repeatedly change the lives of the students, staff, and community who interact with the program.





The Vineyards Award

celebrates an organization having an operating budget of less than \$1 million that effectively addresses serious community problems through passionate staff commitment and the innovative use of volunteers and/or community partnerships.

The New Breath Foundation

VINEYARDS AWARD

The New Breath Foundation mobilizes resources to support Asian American and Pacific Islanders (AAPIs) harmed by the unjust immigration and criminal justice systems to heal, keep families together, and build movements that shift narratives and policies. We are organizers and directly impacted leaders building a community of funders and donors committed to providing hope and healing to AAPIs facing violence, incarceration, and deportation.

NBF Founder and President Eddy Zheng plays a critical role in bridging communities: particularly Black, Asian American, formerly incarcerated, immigrant, and refugee groups. Eddy spent over 20 years in California state prison and immigration jails. During his incarceration, he earned his college degree, mentored youth, and reformed in-prison programming to make them more transformative and culturally relevant. For his leadership and many contributions, Eddy was selected as an Open Society Soros Justice Fellow (2015), Leading Edge Fellow (2019), and Frederick Douglass 200 awardee (2019). Eddy has spent decades creating coalitions to address mass incarceration, deportation, and anti-Black and anti-Asian violence and is uniquely suited to innovate and lead this movement for equitable and representative philanthropy.

NBF provides grants to frontline organizations while simultaneously providing key leadership, support, coordination, and advocacy to advance racial solidarity. As a community-based funder, NBF is uniquely situated within both the philanthropic and community spaces--and will play a key role in educating and advocating philanthropic stakeholders to increase investment in community-grounded racial solidarity efforts. NBF will provide a learning space for philanthropic leaders to educate themselves about the AAPI community's issues and strategies to promote racial solidarity.





The Outstanding Foundation or Grantmaking Organization Award

recognizes a private or community foundation or community grantmaking organization that provides financial support, inspiration, encouragement, and motivation to nonprofits and grantmakers alike—as well as developing innovative approaches to philanthropy.

Eat. Learn. Play. Foundation

OUTSTANDING FOUNDATION OR GRANTMAKING ORGANIZATION

Founded by three-time NBA champion and two-time MVP Stephen Curry and entrepreneur, host, and two-time *The New* York Times bestselling author Ayesha Curry, Eat. Learn. Play. seeks to unlock the human potential of every child. Focused on youth in underserved communities, the foundation's programs are anchored around three core values vital to a successful childhood: nutrition, education, and active living. As emerging figures in the tech and food spaces, the Curry family is committed to increasing access to quality education for K-8 students, driving innovation and creativity, and paving the way for bright futures. The educational focus of Eat. Learn. Play. furthermore, extends through literacy with a goal to close the grade-level reading gap between low-income and minority students and their peers. The foundation's localized programs provide nutritious food for children in low-income neighborhoods to reduce childhood hunger, the tools to learn about holistic wellness and environments for safe play. Since the beginning of the pandemic, Eat. Learn. Play. has partnered with local agencies, nonprofits, and restaurants to provide over 17 million meals and 10 million pounds of groceries to Oakland families, and others in need.





The Outstanding Fundraising Volunteers Award is presented to an individual who has demonstrated exceptional leadership skills in coordinating groups of volunteers at more than one nonprofit for major fundraising projects that benefit charitable institutions and show a commitment to the advancement of philanthropy.

William (Bill) Glenn

OUTSTANDING FUNDRAISING VOLUNTEER

Early in his career, William Glenn was principal of an innercity elementary school in Oakland and vice-principal of private girls' high school in San Francisco.

Glenn has served as board chair for the San Francisco AIDS Foundation, Citizens Funds, a socially responsible mutual fund, and currently is chair of The Graduate Theological Union in Berkeley. He is a past vice-president of KQED.

As the executive of Continuum, in San Francisco's Tenderloin, he led a successful capital campaign for a permanent home to serve many of San Francisco's most beleaguered citizens. He was the vice president at the San Francisco Foundation, wherein his brief tenure, he led an operation that increased the Foundation's fund by \$100M+.

While serving in these capacities, he maintained a practice in clinical psychology, in addition to co-facilitating Katargeo, a men's group for lifers at San Quentin State Penitentiary.

Glenn is a past board member of the Center for Lesbian and Gay Studies in Religion at the Pacific School of Religion and served on the boards of 18th Street Services and the Tenderloin Neighborhood Development Corporation.

Glenn holds three master's degrees. He was awarded the Paul Wesley Yinger Award for Distinguished Preaching from PSR, where he and his husband, Scott Hafner, led a successful capital campaign. More recently, they co-chaired a capital campaign that facilitated acknowledgments of testamentary gifts of more than \$125M for Horizons Foundation and received the Light in the Grove Leadership Award from the National AIDS Memorial Grove. Glenn was awarded the James R. Harrison Leadership Award from the San Francisco AIDS Foundation, the Switzer Leadership Award from New Leaf Services, the AIDS Champion Award from the AIDS Health Project of UCSF, and the Adult Day Health Care Award from San Francisco's Adult Day Health Care collaboration.

His book, I Came Here Seeking a Person: Notes from the Interior, will be published in early 2022.





The Outstanding Foundation or Grantmaking Professional Award

honors a foundation professional who initiates or supports creative nonprofit efforts and develops philanthropic partnerships with organizations and communities in exceptionally effective or unique ways.

Cathy Cha

OUTSTANDING FOUNDATION OR GRANTMAKING PROFESSIONAL

Cathy Cha is president and CEO of the Evelyn and Walter Haas, Jr. Fund. Under her leadership, Haas, Jr. is pursuing new ways to advance equality and justice so every person has opportunities to thrive and live life with dignity and hope.

Cathy's path-breaking approach to collaboration among funders, nonprofits, and government has helped spark wideranging social impact, including California's leadership among states in adopting pro-immigrant policies. To advance racial justice, Cathy joined other community leaders to create the California Black Freedom Fund, a statewide power-building effort. She co-founded Activate California to build a broader constituency of Asian American Pacific Islanders who stand up for justice.

In 2018, Cathy co-created the California Campus Catalyst Fund to expand services for undocumented students across California's higher education systems. Cathy is a founder of the New Americans Campaign, which has assisted 500,000 immigrants to become citizens. She led the California Civic Participation Funders which has increased voting and organizing in five counties.

Cathy is driven by a career-long commitment to improving the lives of aspiring communities facing poverty. She previously worked for the Hyams Foundation, Tenderloin Neighborhood Development Corporation, and United Way of King County.

Cathy is a frequent public speaker on civic engagement, immigration, and innovative philanthropy. In 2019, she was named one of the Most Influential Women in Bay Area Business. She serves on the boards of the California Budget and Policy Center and Coaching Corps. Cathy has a master's degree in city and regional planning from UC Berkeley.





The Outstanding Philanthropist Award is presented to an individual or family with a record of exceptional generosity who, through direct financial support, has demonstrated outstanding civic and charitable responsibility and who encourages others to take philanthropic leadership roles in their communities.

Bruce Braden

OUTSTANDING PHILANTHROPIST AWARD

As a philanthropist, Bruce Braden is a critical thinker, a creative problem-solver, and an advocate for personal enrichment. His contributions are motivated not only by his passion for life but also the challenges faced along the way. Diagnosed with Type 1 diabetes at age 38, Bruce faced the disease head-on with a proactive approach. As a co-founder of the Braden Diabetes Center, Bruce is dedicated to providing the same level of support and education for others less fortunate. That dedication is also reflected in serving on Marin Hospital's board for the past 11 years.

Education in all areas is essential to Bruce's philosophy. In helping to create the Stanford Storytelling Project and the LifeWorks Program for Integrative Learning at his alma mater, Bruce wanted students from any discipline to benefit from the arts. Fulfilling the business side of his wide-ranging interests, Bruce earned his graduate degree at Golden Gate University School of Taxation, now known as the Bruce F. Braden School of Taxation.

Bruce is also a lifelong patron of the arts and has been involved on the board of the Smuin Contemporary Ballet for the past 15 years. In 2019, he was instrumental in helping the company secure a permanent home. Smuin Artistic Director Celia Fushille puts it best: "When he chooses to support an organization, he takes the time to meet the people behind the scenes doing the work."

Through both his personal and philanthropic endeavors, Bruce Braden has demonstrated that the pursuit of wellrounded life is ultimately the most rewarding.





The **Lifetime Achievement Award**

honors an individual or family with a proven lifetime record of exceptional generosity who, through direct financial support, demonstrates outstanding civic and charitable responsibility and whose generosity encourages others to take philanthropic leadership roles in the community.

Lois De Domenico

LIFETIME ACHIEVEMENT

Lois De Domenico was born and raised in Canada by a strong and loving mother. Lois's father passed away when she was 3 years old. At 16, Lois came to San Francisco in 1945 to visit an uncle and met the love of her life, Tom De Domenico. When she was 18, he returned from the war, and they married. Their landlord, Mrs. Captanian taught her to cook rice pilaf which was developed into Rice-a-Roni by the Golden Grain Macaroni Company.

Lois is proud of the four children she raised in San Leandro: Dennis, Donna, Deborah, and Claudia. As they grew up, she became passionate about yoga and helping her community. At 94 years young, she is a volunteer yoga teacher to youth and adults. Lois also has 5 grandchildren and 3 great-grandchildren.

Philanthropy has been a part of her entire life starting with being an advisor for the Candy Stripers at Children's Hospital in San Leandro. For more than 60 years, Lois has served many community organizations benefiting Alameda County residents, providing her time, expertise, and financial support. As a member of the Girls Inc. board of directors, Lois was co-chair of the \$11 million capital campaign to fund a new Girls' Resource Center in Oakland. She has helped achieve a 33 percent rise in donations and recruited a diverse mix of community leaders to its board. Most importantly, Lois has positively influenced scores of underserved girls in Alameda County, teaching them yoga and helping to develop their self-confidence.

Never shy to help her favorite organizations, Lois was Chairperson of the Board for the Oakland Ballet, Easter Seal of Alameda County, East Bay Community Foundation, and was a board member and founder of the Signal Society of KQED and the Stellar Society of Chabot Space and Science Center. LIFETIME ACHIEVEMENT

Born and raised in the Chicago area, Al attended Harvard University and Harvard Law School. In 1958, he moved to San Francisco and worked for Heller, Ehrman, White & McAuliffe. Preferring maps and architecture, Al attended UC Berkeley, earning his master's in City & Regional Planning, and worked for the SF Bay Conservation & Development Commission (BCDC), creating regulations that protect the Bay to this day. Al then led a private city planning firm and developed a real estate investment and renovation business.

Al inadvertently came "out of the closet" in the mid-1970s when he was featured in a SF Chronicle article. Although he knew that being an openly gay man had repercussions, Al had the courage to reveal his true identity and dedicated his life to LGBTQ+ inclusivity.

During the AIDS epidemic, Al earned a master's in Social Welfare from UC Berkeley. As a Licensed Clinical Social Worker, he built a successful private practice, seeing clients well into his 80s.

Al served on several nonprofit boards, including the ACLU of Northern California, New Israel Fund, Jewish Family & Children's Service of SF, Jewish Community Federation, Access Institute, Lamda Legal, Horizons Foundation, and Fine Arts Museums of SF. Al was also a longtime member of Sha'ar Zahav.

At 82, Al was given the Lifetime Achievement Award and served as Grand Marshal of the SF Pride Parade, one of the highlights of his life. Other nonprofits acknowledging Al's invaluable contributions included SPUR, SF AIDS Foundation, Human Rights Campaign, Openhouse, and the Jewish Community Federation.

At age 90, Alvin H. Baum, Jr. passed away in March 2021. He is survived by his husband, Robert, and MANY friends who love him dearly.

HONOREE: Alexandra Aquino-Fike






Hugh "Jesse" Arnelle 1933 - 2020

Jesse attended Pennsylvania State University (PSU), was elected first black student body president. He graduated 1955, and earned a Bachelor of Laws (LLB) from Dickinson School. An Air Force Officer then Peace Corps Director in Turkey and India, Jesse was elected to PSU's Board of Trustees in 1969 and served as President 1994 - 1996. In 45 years as Trustee, Jesse served many roles: President's Club, Renaissance Fund Cofounder (to increase support of minority students), Campaign Committee and Development Council. He received PSU's Lion's Paw Award for Service Excellence. lesse served on many major corporate boards. In addition, he was active in the Charles Houston Bar Association and served as President of SF African American Historical Society.



Alvin H. Baum, Jr. 1930 - 2021

Stephen Davison Bechtel Jr. 1925 - 2021

Stephen Bechtel Jr. was CEO of Bechtel Corporation from 1960 to 1990. Born in Oakland, Stephen graduated Piedmont High School, served in the U.S. Marine Corps, and earned degrees from Purdue and Stanford. As CEO, Stephen oversaw the growth of Bechtel into a world leader in the construction industry, building iconic infrastructure on six continents including the Bay Area Rapid Transit system (BART) in San Francisco. In 1957, Stephen founded the S.D. Bechtel Jr. Foundation making early investments in STEM education and preserving California's environmental resources. The Foundation contributed \$25 million to the Tunnel Top Parkland in San Francisco's Presidio. In 2013 the Foundation was named Outstanding Foundation Grantmaker by the Golden Gate Chapter of the Association of Fundraising Professionals.





Gretchen Berggruen 1945 - 2020

Gretchen Berggruen partnered with her husband, John, to build one of the most prominent modern and contemporary art galleries in San Francisco. "Gretchen was the body and soul of the gallery," said John. Berggruen served on executive committees at the San Francisco Museum of Modern Art. She and her husband made major donations to the collections of SFMOMA and the Fine Arts Museums of San Francisco. The donations to SFMOMA include important works by Roy Lichtenstein, John Baldessari, and Anish Kapoor. The Berggruens facilitated donations of works by Willem de Kooning and Wayne Thiebaud to the Fine Arts Museums, where they are in the permanent collections of the de Young Museum. "Our community has lost an extraordinary spirit and advocate for contemporary art," said SFMOMA Director Neal Benezra.



Shirley Paidar Bogardus 1930 - 2021


Shirley dedicated her time to her family and to teaching about local ecosystems and environmental stewardship. Shirley always had a sparkle in eye and a smile on her face. Her family joked that her blood type was "B positive." She served as President of the Environmental Forum of Marin, as a board member of the California State Parks Foundation and as a board member of the Audubon Canyon Ranch Volunteer Council. She also was a member of the Mill Valley Outdoor Art Club, California Native Plant Society, the Mill Valley Historical Society, the Mill Valley PTA and Friends of Mill Valley Library. Shirley loved the natural environment on and around Mt. Tamaplais and volunteered countless hours teaching children and adults to appreciate and love our natural surroundings.



Arthur Gensler

Arthur Gensler of Mill Valley was a successful architect and entrepreneur. He co-founded the global design firm, Gensler, with his wife Drue. Mr. Gensler believed that the architecture and design profession had a responsibility to take a lead role in addressing environmental challenges. He was bestowed the President's Award by the U.S. Green Building Council. Passionate about education and the arts. Mr. Gensler chaired the board of California College of the Arts where his support led to an expanded campus and a new building in San Francisco. He served on the boards of Buck Institute for Research on Aging, San Francisco Museum of Modern Art, and National Building Museum in Washington, DC. Mr. Gensler was also an active volunteer and donor for his alma mater, Cornell University.





James Catherwood Hormel

An ardent philanthropist and advocate for the LGBTQ community, Jim advanced the rights and dignity of all people. Born in Minnesota, he earned degrees from Swarthmore and University of Chicago Law School. In 1997 President Bill Clinton nominated Jim an Ambassador to Luxembourg - the first openly gay person to represent the United States as ambassador. Jim co-founded the Human Rights Campaign, was founding director of the City Club of San Francisco and served on local and national boards including the American Foundation for AIDS Research. In 1996 he helped create the James C. Hormel Gay & Lesbian Center at San Francisco Public Library and was awarded the **Outstanding Philanthropist** Award by the Association of Fundraising Professionals, Golden Gate Chapter. In 2019, the Golden Gate Chapter honored Jim with the Lifetime Achievement in Philanthropy Award.



Narinder Singh Kapany 1926 - 2020

Narinder Singh Kapany, a pioneering scientist, entrepreneur, and philanthropist who is often described as the "father of fiber optics," Kapany wrote the first book about the new field and played a prominent role in advancing the field. Dr. Kapany and his late wife, Satinder Kapany, were noted philanthropists. They created the Sikh Foundation in 1967, which pioneered the display of Sikh arts at the Victoria and Albert Museum, the Smithsonian Museum, and the Rubin Museum. They established the first permanent Sikh art gallery in the United States at the Asian Art Museum in San Francisco and in Canada at the Montreal Museum of Art. In 1979, Dr. Kapany endowed a Chair in Opto-Electronics at UC Santa Cruz and served on the Board of Trustees at both UC Santa Cruz and Menlo School.



Myung Soon "Mary" Kim 1944 - 2021

Myung Soon "Mary" Kim studied Nursing at Compton College, and received multiple Associate degrees in Arts, Tourism, and Travel from Cañada College. After her husband, Bill S. Kim, became a Trustee at the Asian Art Museum in San Francisco in 1999, Mary began volunteering as a docent, and became a translator and assistant in the Museum's library. In 2003, she received a Korean Presidential Award in recognition of her services to the Korean community, and in 2014, she was a founding Board member of the Korean American Community Foundation of San Francisco (KACF-SF). In 2017, the Smithsonian Institution honored Bill and Mary's modern immigrant story in "Many Voices, One Nation," a permanent exhibition display at the National Museum of American History in Washington, D.C.






Norman Lew 1937 - 2020

Born and raised in San Francisco Chinatown, Norman was dedicated to his family and community from the very start. After graduating from **UC Berkeley and Hastings** Law School, he represented delinquent Chinese youth, the beginning of his lifelong support of protecting the equal dignity of all races, orientations, and people at every stage of life. Norman was a founding member and president of the Asian American Bar Association, board chair of Chinese for Affirmative Action, and a board member of the San Francisco Trial Lawyers Association, reflecting his unwavering commitment to social and legal justice for all.



James Ludwig 1925 - 2020

James Ludwig was a volunteer and extraordinary philanthropic leader whose immense energy, curiosity, insight, and generosity benefited countless Bay Area nonprofits. When asked to take on a project or help someone in need, Jim seldom said "no." During his lifetime Jim served as a 65+ year Board Member of the San Francisco Zoological Society, Trustee Emeritus and 60+ year Board Member of the San Francisco Ballet, Trustee Emeritus of the San Francisco SPCA and of the Hamlin School. He also served as a member of the Board of Directors of "Collectors Forum" of the San Francisco Museum of Modern Art and was a member of the de Young Museum's Advisory Committee for African, Oceania and Art of the Americas.



Cornell C. Maier

Cornell C. Maier, widely respected corporate leader revered for his years of generosity and sage counsel to numerous East Bay causes lived what he believed: "Every able-bodied person has a responsibility to give of his or her time, talent and financial resources to help others." As CEO of Kaiser Aluminum, he launched the "One Person Can Make a Difference" program. As a philanthropic leader he offered advice to numerous organizations and was personally delighted in holding and comforting medically fragile babies at Children's Hospital Oakland. Cornell generosity and guidance benefited Holy Names University, Marcus Foster Educational Institute, Oakland's St. Mary's Center, the Oakland Zoo and many others.






Nancy Wells Maushardt 1930 - 2021

Nancy Wells Maushardt led a full, creative, and accomplished life that was driven by her commitment to Bay Area community service. Janice Mirikitani



Cecil Williams, and San Francisco's poet laureate from 2000 to 2002, Janice was a pillar of strength, inspiration, love, and support. With boundless energy, drive, and empathy for others, Janice used poetry to further the fight for equality in an unjust world. Her radically inclusive work at GLIDE spans five decades; serving the most vulnerable by providing a community refuge of justice and love. Janice was deeply connected to young mothers and children in the Tenderloin and unwaveringly committed to combating systemic inequities and creating new pathways for people experiencing poverty, homelessness, food insecurity, and addiction. She was nonjudgmental, open, loving and kind. There was not one person who she could not help and inspire.



George G. Montgomery, Jr. 1934 - 2020


George was deeply committed to many philanthropic activities, particularly environmental causes and education. Well before climate change was a concept, he felt an urgent need to protect the natural world, explaining, "I don't want to have to tell my grandchildren what a frog was." In 1981, George joined the board of the Environmental Defense Fund, and served as Chair from 1990 - 1997, and remained an engaged Trustee Emeritus until his death. From 2002 - 2011, George served on the board of the California Academy of Sciences and co-chaired their transformative \$500 million capital campaign. He also served as a trustee at The Thacher School and The Buckley School in New York..





Michael Morgan

Maestro Michael Morgan served for 30 electrifying years as the music director of the Oakland Symphony. He successfully diversified the orchestra, its programming, and its audience, and was renowned for his commitment to engaging youth, especially young people of color, in the world of classical music. He was a tireless fundraiser for this cause and helped to vastly increase the size of the orchestra's philanthropic support. He built an Oakland Symphony "dedicated to diversity, education, collaboration, and celebration of music across genres and cultures." He built a legacy that will continue and enhance this work for generations to come.



Mervin G. Morris

Mervin's benevolence reached many people, whether they were customers or employees of Mervyn's stores that he founded in 1949 or neighborhood youth. Mr. Morris served on boards of the Boys & Girls Clubs of America, the California Academy of Sciences, the Jewish Home for the Aged, Mount Zion Hospital, the Palo Alto Medical Foundation, Stanford Hospital, the U.S. Holocaust Memorial Museum, and the University of Southern California. Mr. Morris led fundraising campaigns for the Boys & Girls Club of the Peninsula, and dedicated the Mervin G. Morris Clubhouse in Redwood City. He and his wife "Roz" funded the Roslyn G. Morris Activity Center for the Peninsula Volunteers and supported San Francisco's Opera and Symphony.



Eunice Motte Jackson

Eunice Motte Jackson's varied career in community service and volunteerism spanned more than five decades. She was an active volunteer for Saint Mary Magdalen Parish in Berkeley, St. Mary's College High School, Catholic Charities and Berkeley Community Y.W.C.A. She founded and for 21 years ran Project Friend serving developmentally challenged teens and young adults in Berkeley. Through her work with the Bay Area Urban League and the San Francisco Chapter of Links, Inc., Eunice served African American communities and inspired countless people with her commitment to community service, compassion for others and remarkable humility. As one of her colleagues said, "Eunice wasn't looking for accolades for her work, she just did."





Grant Moy 1917 - 2021

Dr. Grant Moy was a Congressional Gold Medal honoree and accomplished surgeon, who blazed trails in the 1940s as a medical resident and young Army doctor during World War II, despite the racial prejudice he encountered. In 1952, Dr. Moy became one of the first two Chinese Americans in the state ever to receive American Board certification in General Surgery. He set up a practice in San Francisco, where he served the community for five decades. Dr. Moy helped establish the Chinese Community Health Care Association, served on the Board of Directors of the Chinese Hospital, and helped to raise funds to support the expansion of the hospital and its services. Dr. Moy also taught for many years at the University of California San Francisco School of Medicine.



Margaret Ishiyama Raffin 1946 - 2021

Inspired by experience as a medical social worker, Margaret was a lifelong advocate for mental health services and access to healthcare. At her alma mater, Stanford University, where she received the Stanford Associates Governors' Award, she established the Stanford Medicine Community Council, served on the Stanford Health Care board, and supported numerous endeavors. As president of the Ishiyama Foundation, Margaret championed a range of causes, focusing on education, investigative journalism, and the environment, and contributed to local organizations through the Palo Alto Community Fund. She directed grants to leadership development in the U.S. and abroad and to protecting Western landscapes and institutions, serving on the boards of the National Parks Conservation Association and Maui Arts and Cultural Center.



Ann Reynolds 1935 - 2021

Ann, a Piedmont resident, attended Wellesley College, UC Berkeley. With her MS in **Educational Psychology and** California School of Counseling credential, Ann mentored students and created scholarships at Northern Lights School, Wellesley, UC Berkeley, Holy Names and through the Oakland Coliseum Foundation. She served on Boards of Independent Educational Consultants Association. Piedmont Millennium High School, Junior League of the East Bay and Northern Light School. Ann was honored with the lifetime achievement award from Ann Martin Children's Center, the President's Medal of Honor for contributions to Holy Names, and the Durocher Award. Ann cofounded A Beautiful Night Housing, a nonprofit farm for young adults living with mental illness, and LookUp.live, a nonprofit to counter the impact of digital addiction and social isolation on youth.





Frances "Frankie" Rhodes

Frances "Frankie" Hayden Rhodes left a beautiful, visible legacy for the city of Oakland and for the Bay Area's historic preservation community. Frankie was a founding member of the Camron-Stanford House Preservation Association (CSHPA), which preserved and restored the last of the 19th-century Victorian mansions that once surrounded Lake Merritt. For five decades, she worked passionately as a board member, volunteer, and docent to celebrate the architecture, art, and history of the Camron-Stanford House and to interpret it for visitors. Frankie was also active in the Junior League of the East Bay, Decorative Arts Forum, Art League of the East Bay, Oakland Museum docent program, Victorian Alliance, and Victorian Society.



David Sanchez Jr., Ph.D. 1939 - 2020

Dr. Sanchez, a dean and professor at UCSF, was especially interested in issues related to diversity, seniors, and veterans. He was a member of California's Commission on Aging, San Francisco's Health Commission, and Zuckerberg SF General Hospital's advisory board. Dr. Sanchez was president of the city's police commission and the school board. He served on the boards of San Francisco's Catholic Charities, Centro Latino, Columbia Park Boys & Girls Club, San Francisco Community College, the SF Education Fund, the Maritime Association, and the San Francisco Foundation. Dr. Sanchez was a member of the American GI Forum.



Leo Soong 1946 - 2021


Leo Soong of Walnut Creek, co-founder of the Crystal Geyser Water Company, served in leadership roles in industry, community, and faith organizations. He received degrees of distinction from Stanford and Harvard Business School. Fluent in more than 6 languages, Mr. Soong received 2 patents. He often addressed audiences about his uncle, Chiang Kai -shek, former leader of Taiwan. Mr. Soong and his wife Shirley worked as missionaries in challenging conditions, once eating only cabbages and potatoes for a month in Siberia. Mr. Soong served on the board of AAA Northern California, Nevada and Utah for more than 20 years. Other board affiliations included PBS, KQED, Sutter West, Christian Witness Theological Seminary, Multnomah University, California Pacific Medical Center, ACA Holdings, and Barclay's Global Investors Funds





Joyce Stupski 1945 - 2021

Co-founder, with her spouse Larry, of the Stupski Foundation, Joyce dreamed big about what could be, not content with just what is today. In all of her endeavors, Joyce was deeply caring and endlessly imaginative. Her passion for improving public education was informed by her work teaching students with special needs in the San Francisco Unified School District. After Larry's passing in 2013, Joyce converted the Foundation's assets into a spend-down to address urgent challenges in food security, postsecondary education, early brain development, and serious illness care. Under her leadership, Joyce directed the Foundation to always focus on the people served by its grantmaking. Joyce embodied the Foundation's motto, "Because change can't wait."



John Sutter

Judge John Sutter was a powerful and tireless advocate for the Bay Area shoreline and environment for over 60 years. A co-founder of the organization that became Greenbelt Alliance and member of the Bay Conservation and Development Commission, he also served as a board member and fundraiser for Save the Bay, Sierra Club, YMCA, Oakland Citizens Committee for Urban Renewal, and more. One of his enduring achievements was securing the land at the base of the Bay Bridge for the John Sutter Regional Shoreline Park, which is enjoyed by thousands.



Linda Trowbridge

Linda Trowbridge's 35-year career as a healthcare executive in the Bay Area concluded as CEO of Center for Elders' Independence, the communitybased healthcare provider in the East Bay of PACE, or Program of All-inclusive Care for the Elderly), dedicated to providing frail, mostly low-income elders with an alternative to nursing home care. She served on the Boards of San Francisco's PACE, On Lok, for 17 years and Hospice East Bay. Linda shepherded 70 young men through the process of obtaining their Eagle Scout awards with the Piedmont Boy Scout Council and served on the Board of Elders of College Avenue Presbyterian Church. Linda helped ovarian cancer research by participating in aggressive studies and treatments, including a clinical trial at the Mayo Clinic during the last months of her life.






